## Completion of Placement and Cleansing Notice

Alma Metals Limited (the "Company") (ASX: ALM) advises that further to its announcement of 23 May 2023 titled "\$2.0M Placement to Fund Additional Drilling at Briggs, QLD", it has now completed Tranche 2 of the Placement by the issue of 10,000,000 ordinary shares at an issue price of \$0.01 per share ("Placement Shares").
