As set out in the Notice of Meeting dated 16 June 2023, and approved by securityholders on 24 July 2023, 5,368,042 units are being issued by HCW in lieu of cash to the Investment Manager (being HMC Investment Management Pty Ltd) or its nominee to satisfy the acquisition fee that arose as a result of tranches 1 and 2 of the acquisition by HCW of a 100% interest in four mental health and rehabilitation hospitals and an approximately 50% interest in a further seven hospitals via its investment in the Unlisted Healthcare & Life Sciences Fund. The acquisition fee represents a one-off payment of \$7.3 million, divided by \$1.3599, being the five-trading day VWAP of units up to Thursday, 18 May 2023 (the completion date of tranches 1 and 2 of the acquisition).
