On 4 September 2023, 185,935 fully paid ordinary shares in Megaport Limited (**Shares**) were issued to eligible employees on conversion of the same number of PBI RSUs.

On 1 December 2022, Megaport granted 19,900 Restricted Stock Units under the Megaport Restricted Stock Unit program to eligible employees (**RSUs**). On 4 September 2023, 19,900 Shares were issued to eligible employees on conversion of the same number of RSUs.

On 1 September 2022, Megaport granted a certain AUD value worth of Shares under the Megaport Restricted Stock Unit program. Under the program, the number of Shares to be issued, transferred or allocated to eligible employees on the issue date is to be calculated by dividing the Share Value by the volume-weighted average price of Shares in the 10 consecutive trading days prior to (and excluding) the issue date (VWAP), and rounded down to the nearest whole Share.
