Under the program, the number of Shares to be issued, transferred or allocated to eligible employees on the issue date is to be calculated by dividing the Share Value by the volume-weighted average price of Shares in the 10 consecutive trading days prior to (and excluding) the issue date (VWAP), and rounded down to the nearest whole Share. For the purposes the Appendix 3G lodged with ASX on 1 September 2022 in respect of the 1 September 2022 grant, the number of Shares to be issued, transferred or allocated under the program was calculated using an assumed VWAP of AUD \$7.26. However, it was noted that the VWAP at the time of the relevant issue may be higher or lower, resulting in a lesser or greater number of Shares being issued.</p> <p>The actual VWAP at the issue date was AUD \$11.893302. Accordingly, the number of Shares issued to eligible employees was 957 (Share Value of \$11,385.09).
