The vesting conditions for the FY24 Performance Rights will be contained in the Notice of Meeting to be sent to shareholders to approve the issuance of 500,000 PRs to Mark Bayliss, Executive Chairman in late Oct 2023. It is based off a 10% increase CAGR in TSR over a 3-year period.
