### **Megaport Limited – Appointment of Chief Financial Officer**

Megaport Limited ACN 607 301 959 (**Megaport**) (**ASX: MP1**) today announced that following the completion of a global executive search, Ms Leticia Dorman has been appointed to the role of Chief Financial Officer (CFO), effective 3 October 2023. Ms Dorman has performed the CFO role in an interim capacity since 28 March 2023.

Ms Dorman will be responsible for overall financial management, reporting, budgeting, taxation, risk management, audit, and compliance. She will report directly to Megaport's Chief Executive Officer, Michael Reid.

Prior to her appointment as interim CFO in March this year, Ms Dorman held the role of Head of Finance, with responsibility for management of the Finance function, and led the project to enhance the operational efficiency of the Company's financial systems, processes and reporting. Ms Dorman joined the Company in 2021 from Brisbane Airport Corporation, where she was Head of Commercial Revenue with responsibility for business partnering with the retail, industrial, and property teams. Prior to that, Ms Dorman worked for Megaport as Financial Controller APAC and North America. Ms Dorman has more than 15 years' experience in finance roles.

"Her deep knowledge of Megaport's business, ability to think strategically and commercially, and her clear focus on financial discipline adds strong value to our leadership team as we continue to drive profitable growth."
