At its AGM on 31 March 2023 AMP shareholders approved the buy-back of up to 500 million shares on-market. AMP intends to buy-back up to \$255m of its fully paid ordinary shares under the current on-market buy-back. Dividends paid to shareholders on 3 April and 29 September account for other amounts of capital returned since the announcement for a buy-back of up to \$325m was released. Updates for other capital return plans were disclosed with the half year results on 10 August.
