# **September Quarter (Q1 FY24) Quarterly Activities Report and 4c Results**

### **Highlights;**

- **Metrics for Q1 FY24 show continued growth for all Camplify Holdings Limited markets**
- **Combined global GTV of \$41.5m (unaudited) including vans, representing a pcg growth of 106.7%**
- **Combined global Revenue of \$11.7m (unaudited) including vans, representing a pcg growth of 114.2%**
- **4th Consecutive quarter with a positive net cash from operating activities. A total of \$0.08m an improvement from (\$1.6m) in Q1 FY23**
- **CHL recorded cash receipts of \$36.5m, a pcg growth of 58.7%**
- **Camplify markets show strong customer demand closing out the quarter with a total of \$29.5m (unaudited) in future bookings, representing a pcg growth of 32.6%**
- **Total global fleet of 29,207, a pcg growth of 166.5%**
- **Global Take rate hit 28.2% an increase from 27.2% pcg (unaudited, including van sales)**

Camplify Holdings Limited ('CHL' or 'the company') is pleased to announce its Q1 FY24 results. Camplify saw GTV and Revenue growth in all markets, and while we do not have comparable periods for PaulCamper yet, PaulCamper are performing in line with expectations.

In Q1 FY24, CHL achieved a global gross transaction volume (GTV) of \$41.5m (unaudited), representing growth of 106.7% compared to Q1 FY23. The Camplify markets contributed \$28.5m GTV.

Global revenue grew to \$11.7m in Q1 FY24 (unaudited), up 114.2% pcp. Camplify markets generated revenue of \$9.1m.

CHL recorded its 4th positive quarter of net cash from operating activities of \$0.08m (unaudited). This compares to (\$1.6m) in Q1 FY23, demonstrating improved cash generation and financial stability within our operations.

Recorded cash receipts from customers of \$36.5m in Q1 FY24, up 58.7% pcp (unaudited).

Future bookings continue to show strong growth. Q1 FY24 future bookings closed at \$29.5m (unaudited), representing an increase of 32.6% compared to Q1 FY23. This growth reflects strong customer demand. Please note, future bookings do not include PaulCamper due to differing revenue recognition based on booking paid date.

The UK market was a standout market this quarter. In The UK market we refined our marketing approach in Q4 FY23 with a focus on owner engagement and hirer activation and a multichannel approach to acquisition. This refinement has seen The UK market go from Q1 FY23 negative growth of -14.9% to positive growth in Q1 FY24 of 156.1% (unaudited), continuation of these strategies in The UK market will enhance and optimise the market moving forward. The average booking value remained high at \$1,524.63.

The New Zealand market again exhibited strong growth during a low season quarter, with a GTV increase of 143.7% compared to Q1 FY23. With an average booking value of \$1,647.93 and forward bookings of \$7.3m showing strong customer demand for the upcoming high season.

Progress also continues on our strategic insurance initiative, MyWay Insurance, with MyWay launching in the EU markets of Germany, The Netherlands and Austria. This

positions CHL to deliver enhanced insurance products and services to customers. Work continues to launch MyWay Insurance into our other markets this financial year.

Van sales contributed \$0.4m GTV and revenue in the quarter (unaudited), as we maintain our focus on branded built fleet and higher margin products.

The combined global take rate was 28.2%, an increase from 27.2% pcp (unaudited, including van sales). Excluding PaulCamper regions, take rate was 32.0%, with the increase relating to additional AER sales (54.1% of bookings upgraded AER during the quarter), increased Premium Members and higher van sales for the quarter. This demonstrates the strength of our core marketplace model as we continue to improve the PaulCamper markets take rate.

The migration of the PaulCamper business to the core CHL technology stack is underway and due for completion in Quarter 3. Core to the CHL acquisition strategy for PaulCamper was to consolidate technology, and introduce new products to the PaulCamper markets. This migration will allow CHL to introduce Premium Membership to our European markets, offer dynamic pricing throughout the seasonality of the markets, introduce new insurance offerings, and provide an improved user experience. We anticipate these changes will allow CHL to focus on takerate improvements towards the global takerate of 28.2%, and the rollout will begin in Q3 FY24.

With these strong results, CHL has sustained its growth trajectory and remains in a leading position in the global RV rental marketplace.
