Performance Rights are subject to a vesting condition of continued employment from grant date to the relevant vest date. Subject to the satisfaction of the employment vesting condition, Performance Rights will vest:

- One third (140,088) on 1 July 2024;

- One third (140,088) on 1 July 2025; and

- One third (140,322) on 1 July 2026.

If the vesting condition is not satisfied, or otherwise waived by the Board, Performance Rights will lapse.

A further 17,885 Performance Rights have been offered to the Company's Managing Director, Zoran Bebic, with the issue being subject to shareholder approval under listing rule 10.14.

Any shares acquired on exercise of Performance Rights will be restricted from disposal until the earlier of:

- the opening of the share trading window following the release of the 30 June 2026 financial results (in or around August 2026); and

- the date on which the employee ceases to be employed by the Company or its subsidiaries.
