ACTIVITIES REPORT AND APPENDIX 4C –
QUARTERLY CASH FLOW REPORT SEPTEMBER 2023

Adelaide, Australia, Tuesday 31 October 2023: Axiom Properties Limited (ASX:AXI) lodges the attached Appendix 4C Quarterly report for entities admitted on the basis of commitments for the quarter ended 30 September 2023.

The Company's cash reserves for the September quarter decreased by \$4.710 million and the Company held cash reserves of \$6.400 million as at 30 September 2023.

The below should be read in conjunction with Operational and Strategic Update released to the public on the ASX on 27 October 2023.

Details of the Company's business activities for the quarter are as follows:

- o \$1.063 million of the operating cash outflow related to timing of the GST payment on the Butler Central Homemaker Centre Final Development Fee of \$11.046 million (net of GST and settlement adjustments), received in the previous quarter.

The balance of net operating cash flows for the September quarter included cash out flows of employee, office overhead and interest costs as disclosed in item 1 in the below 4C, which are representative of regular quarterly operating costs.

- o As announced in the previous quarter's report, Axiom acquired additional shares in Openn at a cost of \$0.726 million, such that it now owns 19.99% of the Company, payment for which occurred in July 2023 and is accordingly recorded in this quarter.

Axiom agreed to invest net \$1.500 million by way of a Convertible Note in Realty Assist which was paid during the quarter, which attracts an enhanced return through a significant coupon accrued through the term of the note as well as Axiom having the right to convert at expiry into equity in the Realty Assist business.

Through its subsidiary Fletch Capital, the Company secured the ownership of a financial and lending software technology and payment platform as well as an Australian Credit Licence (ACL) and preferential supply-side partnerships (\$0.700 million).

- o The financing cash outflows for the September quarter of \$0.066 million relate to the right of use lease liability of the Adelaide and Sydney offices and motor vehicle.
- o Aggregate amount of payments to related parties and their associates are for director fees and salaries and wages, as well as for costs incurred on behalf of the Company in the ordinary course of business, which were reimbursed at cost.

The Board and its executives continue to monitor operating and overhead costs to ensure the Company remains in a strong financial position. There were no substantive changes to business activities during the quarter.
