CAQ Holdings Limited September 2023 Quarter Activities Report

Operations Review

The property leasing business dropped by approximately 30% in September 2023 Quarter due to delay in payment and reduction of lease area by tenants for factories and warehouses. Leasing revenue totalled RMB2.3 million during the September 2023 Quarter and that for the June 2023 Quarter was RMB3.33 million.

The status of the exhibition centre remained similar of the June 2023 Quarter, the system integration testing was still not completed, particularly in the online face swiping payment system required more time to fix minor technical issues identified during testing.

The existing vacancy (including areas subject to negotiation) rate being:

Warehouse $(41,750m^2)$	30%	(24% in June 2023)
Factories (17,784m ²)	28%	(28% in June 2023)
Exhibition Centre*	89%	(100% in June 2023)
Administrative Building	46%	(46% in June 2023)

Work is continuing on securing new tenants for all areas with a number of contracts under negotiation.

During the September 2023 Quarter CAQ's receipts from customers was \$506k (RMB2.37 million) which was slightly down on the June 2023 quarter \$542k (RMB2.54 million).

The inventories of Kingmall continue to be sold online. Kingmall is searching new suppliers of goods and negotiation was in progress.

Financial

At the end of the Quarter the Group had cash at bank of \$0.63m. Inventories were sold continuously to fourth parties to improve the cash position of the company in the fourth quarter. However, since the market price of diamond dropped significantly in the past twelve months, loss from disposal of inventories was anticipated and will be reflected in the December 2023 Quarter.

Payments to director related parties and their associates during the quarter totalled \$Nil.
