The Plan's purpose is to provide an opportunity for each Non-Executive Director (NED) to increase their shareholding in a tax effective manner. At the beginning of the participation period (1 September 2023 to 31 August 2024), NEDs can nominate a percentage of their pre-tax fees (up to 100%) to receive in Rights to shares. Rights vest and convert to shares following the completion of the participation period. The rights do not have any performance conditions in order to preserve the NEDs' independence. Shares received on exercise will be subject to a disposal restriction of at least three years, or longer as nominated by the NED (up to 15 years from grant date). If a participant ceases to be a NED prior to the Rights vesting, a pro-rata number of Rights will convert to shares on the date of cessation and the shares will remain subject to the applicable restriction period.
