The Non-Executive Directors (NEDs) have elected to participate in the NED Equity Plan. The NEDs elect to sacrifice a portion or the whole of their NED fees in exchange for Endeavour ordinary shares. The Share Rights granted to the NEDs on 8 November 2023 have vested and been converted into Endeavour ordinary shares on a one-for-one basis. The Share Rights were satisfied by allocating ordinary shares from the Endeavour Group Employee Equity Plan Trust (Trust), which were purchased on-market. The ordinary shares are held by Pacific Custodians Pty Limited, as trustee of the Trust, for the NEDs until the end of the nominated restriction period.
