Lovisa Holdings Limited (LOV) – Results of 2023 Annual General Meeting

In accordance with ASX Listing Rule 3.13.2 and section 251AA of the Corporations Act 2001 (Cth), Lovisa Holdings Limited (ASX:LOV) advises the voting results of all resolutions and proxies received as set out in the attached proxy and voting summary.

All resolutions were passed by way of a poll with the required majority of votes, with the exception of Resolution 2 which was not passed. As more than 25% of the votes cast on Resolution 2 were against the adoption of the 2023 Remuneration Report, this constitutes a 'first strike' for the purposes of the Corporations Act 2001 (Cth).
