Amended constitution - Industria Trust No. 2

Dexus Industria REIT (ASX:DXI) comprising of Industria Trust No. 1, Industria Trust No. 2, Industria Trust No. 3 and Industria Trust No. 4 (Trusts) and Industria Company No. 1 Limited (Company) together the stapled group, advises that at the Annual General Meetings on 23rd November 2023 the securityholders of each entity in the stapled group approved by special resolution to re-insert the proportional takeover provisions in the respective constitutions for a further three year term. Specifically, this means re-insertion of clause 13 of the Company's constitution, clause 5.29 of each of Industria Trust No. 1's and Industria Trust No. 2's constitution and clause 4.10 of each of Industria Trust No. 3's and Industria No. 4's constitutions in the same form that they were previously included in each constitution.

Attached is a copy of the amended Industria Trust No. 2 constitution. A separate announcement will be made for each entity.

Recitals

- A The Responsible Entity is the trustee and responsible entity of the registered scheme known as the Industria Trust No. 2 ARSN 125 862 491 (**Trust**) established under a constitution dated 29 April 2002 and amended on 20 November 2014 (**Constitution**).
- B Clause 24.1 of the Constitution provides that subject to any approval required by law, the Responsible Entity may by deed amend the Constitution.
- C On 22 June 2016, the Australian Securities and Investments Commission issued ASIC Corporations (Attribution Managed Investment Trusts) Instrument 2016/489 (**ASIC Instrument**), which permits the responsible entity of a registered scheme to modify the constitution of the scheme to the extent that the responsible entity reasonably considers that the modification is necessary for, or incidental to, the scheme being able to be operated in a manner permitted by the *Income Tax Assessment Act 1997* (Cth) as an attribution managed investment trust (**AMIT**) with the responsible entity as its trustee.

It is declared as follows:

1 Definitions and interpretation

1.1 Definitions

Unless otherwise defined in this Supplemental Deed Poll (including the recitals), terms defined in the Constitution bear the same meaning when used in this Supplemental Deed Poll.

1.2 Interpretation

- (a) Clause 30 of the Constitution applies to this Supplemental Deed Poll as if set out in this Supplemental Deed Poll.
- (b) Headings are inserted for convenience only and do not affect the interpretation of this Supplemental Deed Poll.

1.3 Benefit of the Supplemental Deed Poll

- (a) This Supplemental Deed Poll is made by the Responsible Entity with the intent that the benefit of this Supplemental Deed Poll shall apply to the benefit of Members jointly and severally.

-
- (b) This Supplemental Deed Poll amends the Constitution and is binding on:
- (i) all Members (as they are constituted from time to time); and
 - (ii) the Responsible Entity.

2 Amendment of Constitution

The Responsible Entity declares that the Constitution is modified as set out in Schedule 1.

3 No resettlement

The Responsible Entity confirms that it is not by this Supplemental Deed Poll intending to:

- (a) resettle or redeclare the unit trust declared under the Constitution; or
- (b) cause the transfer, vesting or accruing of any property comprising the assets of the Trust in any person.

4 Effect of amendments

The amendments to the Constitution do not affect the validity or enforceability of any other provisions of the Constitution.

5 When amendments take effect

The amendments to the Constitution set out in this deed take effect immediately upon the conditions set out in paragraph 3(b) of the ASIC Instrument having been met.


6 Governing law and jurisdiction

Operative provisions:

This deed poll is declared by Australand ~~investments~~Investments Limited to be the constitution of Australand Wholesale Property Trust No. 6A.

1 Name of Trust

- 1.1 The Trust is called the Australand Wholesale Property Trust No. 6A or by such other name as the Responsible Entity determines by resolution of its board of directors from time to time.
- 1.2 If the name of the trust at any time implies an association with the Responsible Entity or its business and the Responsible Entity retires or is removed, its successor as Responsible Entity must, unless otherwise approved by the former Responsible Entity, change the name of the Trust to a name that does not imply an association with the former Responsible Entity or its business.

2 Registered Scheme

- 2.1 While the Trust is not a Registered Scheme this constitution is to be read subject to Schedule 1.

3 Assets held on trust

- 3.1 The Responsible Entity must hold the Assets on trust for Members. Subject to law, the Responsible Entity may arrange for Assets to be held by a custodian.
- 3.2 Any Assets held by the Responsible Entity as responsible entity of the Trust, must be clearly identified as property of the Trust and held separately from the assets of the Responsible Entity and any other managed investment scheme if and to the extent that the Corporations Act so requires.

4 Application of AMIT Regime to the Trust

- 4.1 If the Trust meets the qualification requirements set out in the AMIT Regime, the Responsible Entity may make an AMIT Choice.
- 4.2 If an AMIT Choice is made, then subject to clause 4.3, the provisions in Schedule 3 will prevail over any other provisions of this document to the extent of any inconsistency, if such an inconsistency is not adverse to Members' rights.
- 4.3 If the Trust ceases to be an AMIT for any reason, including but not limited to the Trust ceasing to meet the qualification requirements to be an AMIT in respect of a Financial Year:
 - (a) the provisions of Schedule 3, except those in clause 1 of Schedule 3 which will continue to be applied by the Responsible Entity, will cease to apply to the extent that they are not permitted to operate or are not relevant to the Trust when it is not an AMIT; and

(b) any provision of the AMIT Regime which applies to an entity that is a former AMIT will continue to apply to the Trust.

4.4 Nothing in this clause 4 imposes an obligation on the Responsible Entity to:

(a) enter into or facilitate the entry of the Trust into the AMIT Regime;

(b) make any changes to this Constitution; or

(c) make an AMIT Choice.

45 Units, Classes and Options

Nature of Units

4.15.1 The beneficial interest in the Trust is divided into Units.

4.25.2 Subject to any rights, obligations and restrictions attaching to any particular Units or Class:

- (a) each Fully Paid Unit confers an equal undivided interest;
- (b) a Unit confers an interest in the Assets as a whole, subject to the Liabilities; and
- (c) a Unit does not confer an interest in a particular Asset.

Classes

4.35.3 Subject to the Corporations Act, the Responsible Entity may create and issue Classes with such rights, obligations and restrictions attaching to the Units of such Classes as it determines and provide for conversion of Units from one Class to another Class.

Stapling provisions

4.45.4 The provisions of this constitution relating to Stapling will only take effect on and from the Stapling Commencement Date and will apply subject to all other provisions of this constitution which may suspend, abrogate or terminate Stapling.

Options

4.55.5 The Responsible Entity may create and issue Options on such terms and conditions as the Responsible Entity determines. Options may be issued with Units or separately.

4.65.6 On the exercise of an Option, the Option Holder is entitled to subscribe for and be allotted such number of Units as the terms and conditions of the issue of the Option contemplate.

4.75.7 Subject to this constitution, the Corporations Act (and the conditions of any applicable ASIC relief from it) and, if relevant, the Listing Rules, the Responsible Entity may determine that Options will be issued:

- (a) for no consideration;
- (b) on the basis that the exercise price for a Unit to be issued on exercise of the Option is the price determined by the Responsible Entity, provided that the exercise price is

less than the price that would otherwise apply under this constitution by a percentage not exceeding 50%; and

- (c) conferring on the Option Holder such other entitlements under this constitution as the Responsible Entity determines,

and otherwise on terms and conditions and with such entitlements as determined by the Responsible Entity. The terms of issue of the Option may allow the Responsible Entity to buy back the Options.

4.85.8 Subject to the Listing Rules and the Corporations Act (and the conditions of any applicable ASIC relief from it), if the Responsible Entity is making an offer of Options to Members which is otherwise in proportion to their existing holdings of Units, the Responsible Entity is not required to offer Options under this clause to persons whose address on the Register is in a place other than Australia and New Zealand.

Exercise of Options

4.95.9 On exercise of an Option, the Option Holder is entitled to subscribe for and be allotted such number of Units as the terms and conditions of issue of the Option contemplate.

4.105.10 While Stapling applies, an Option may only be exercised if, except in the case of Units which are to be APG Held Units (where applicable) at the same time as Units are acquired pursuant to the Option, the same person acquires an identical number of Attached Securities, which are then Stapled to the Units.

4.115.11 A Member holds a Unit subject to the rights, restrictions and obligations attaching to that Unit or that Class of Unit. An Option Holder holds the Option subject to the terms and conditions attaching to that Option.

No fractions of Units

4.125.12 Fractions of a Unit may not be issued.

4.135.13 Where any calculation performed under this constitution or the terms of a withdrawal offer results in the issue or redemption of a fraction of one Unit, the number of Units to be issued or redeemed is, subject to this constitution, to be rounded down or up respectively to the nearest whole Unit.

4.145.14 Any excess application or other money or property which results from rounding under any provision of this constitution becomes an Asset.

Reorganisation and division of Units and Options

4.155.15 Subject to the Listing Rules and the Corporations Act, Units and Options may be consolidated, divided or converted in a ratio as determined by the Responsible Entity (**Reorganisation**). If any Unit is a Partly Paid Unit at the time of Reorganisation the unpaid amount of the Application Price and any instalment payable in respect thereof will be amended in the same ratio.

4.165.16 Each Member, by subscribing for or taking a transfer of, or otherwise acquiring, a Unit or Option will be taken to have consented to Reorganisations.

4.175.17 To effect any Reorganisation of a Unit or Option of a Member, the Member appoints the Responsible Entity as the Member's attorney in the Member's name and on the Member's

behalf to do all acts and things which the Responsible Entity considers necessary, desirable or reasonably incidental to effect the Reorganisation of the Unit or Option.

Reorganisation while Stapling applies

4.185.18 While Stapling applies, Units may be subject to Reorganisation only if the related Attached Securities are also subject to Reorganisation at the same time and to the same extent.

Form of Transfer

4.195.19 Transfers must be in a form approved by the Responsible Entity accompanied by any evidence reasonably required by the Responsible Entity to show the right of the transferor to make the transfer and (if the Responsible Entity requires) be presented for Registration duly stamped.

Registration

4.205.20 A transfer is not effective until Registered.

Transfer of Units and Options if not Officially Quoted

4.245.21 Members may transfer Units and may also transfer Options subject to their terms and conditions.

4.225.22 If Units or Options are not Officially Quoted, the Responsible Entity may only refuse to record any transfer in the Register if, in the opinion of the Responsible Entity:

- (a) the transfer does not comply with clause [5.195-194.19](#) or Schedule 2;
- (b) the creditworthiness of the proposed transferee suggests that the transfer would be materially prejudicial to the interests of the Members as a whole or the Responsible Entity;
- (c) the transferee is not an investor who has the financial ability and willingness to accept the risks and lack of liquidity inherent in an investment in the Trust;
- (d) on registration of the transfer, the transferee will not be bound by all the obligations of the transferor Member in relation to an APT Proposal;
- (e) the transferee is not an Eligible Person;
- (f) the transferee is not a Qualified Investor; or
- (g) there are material legal, tax, stamp duty or regulatory reasons which mean the Registration of the transfer would be prejudicial to the interests of the Members as a whole or the Responsible Entity.

Transfer of Units and Options if Officially Quoted

4.235.23 If the Units and/or Options are Officially Quoted, Units and/or Options may be transferred in any manner permitted by the Operating Rules of a CS Facility. The Responsible Entity may require before registration of any such transfer that there be provided to the Responsible Entity any documents which the rules of the uncertificated system require or permit the Responsible Entity to require be provided to it to authorise registration. clause ~~5.235-234.23~~ prevails over any other provision of this constitution that may be inconsistent with it but it does not permit the Responsible Entity to refuse to register a proper transfer made in accordance with the Operating Rules of a CS Facility.

Responsible Entity may request holding lock or refuse to register transfer

~~4.245.24~~ If Units or Options are Officially Quoted, and if permitted to do so by the Listing Rules, the Responsible Entity may:

- (a) request any applicable CS Facility Operator or Registrar, as the case may be, to apply a holding lock to prevent a transfer of Units or Options registered on the CS Facility's subregister or registered on an issuer-sponsored subregister, as the case may be; or
- (b) refuse to register a transfer of other Units in the Trust.

Responsible Entity must request holding lock or refuse to register transfer

~~4.255.25~~ If Units or Options are Officially Quoted, the Responsible Entity must:

- (a) request any applicable CS Facility Operator or Registrar, as the case may be, to apply a holding lock to prevent a transfer of Units or Options registered on the CS Facility's Subregister or registered on an issuer-sponsored subregister, as the case may be; or
- (b) refuse to register any transfer of other Units in the Trust;
if:
 - (c) the Listing Rules require the Trust to do so;
 - (d) registration of the transfer is prohibited by clause ~~5.29(b)5.29(b)4.29(b)~~; or
 - (e) the transfer is in breach of the Listing Rules or a Restriction Agreement.

Notice of holding locks and refusal to register transfer

~~4.265.26~~ If in the exercise of its rights under clauses ~~5.245-244.24~~ and ~~5.255-254.25~~ the Responsible Entity requests application of a holding lock to prevent a transfer of Units or Options or refuse to register a transfer of a security they must give written notice of the request to the holder of the Units or Options, to the transferee and the broker lodging the transfer, if any. Failure to give such notice does not invalidate the decision of the Responsible Entity.

Responsible Entity must retain instruments of transfer

~~4.275.27~~ The Responsible Entity must retain every instrument of transfer which is registered for such period as the Responsible Entity determines.

Return of refused transfers

~~4.285.28~~ If the Responsible Entity refuses to register a transfer, the transfer must be returned to the person who deposited it if demand is made within 12 months of the giving of notice of refusal to register unless there has been an allegation of fraud concerning the transfer or the transaction to which it relates.

Proportional takeover offers

~~4.295.29~~ Notwithstanding the foregoing provisions of this clause ~~5.44~~ if offers are made under a proportional takeover bid for Units of the Trust in accordance with the Corporations Act:

- (a) clauses ~~5.295.294.29~~ to ~~5.345.344.34~~ apply:
- (b) the registration of a transfer giving effect to a takeover contract resulting from acceptance of an offer made under the takeover bid is prohibited unless and until a resolution to approve the bid is passed or taken to be passed in accordance with clause ~~5.325.324.32~~ or ~~5.335.334.33~~; and
- (c) the Responsible Entity must ensure that a resolution to approve the bid is voted on in accordance with clauses ~~5.305.304.30~~ and ~~5.315.314.31~~ before the fourteenth day before the last day of the bid period.

- (b) by means of a postal ballot conducted in accordance with the following procedures:
 - (i) a notice of postal ballot and ballot paper must be sent to all persons entitled to vote on the resolution not less than 14 days before the date specified in the notice for closing of the postal ballot, or such less period as the Responsible Entity determines the circumstances require;
 - (ii) the non-receipt of a notice of postal ballot or ballot paper by, or the accidental omission to give a notice of postal ballot or ballot paper to, a person entitled to receive them does not invalidate the postal ballot or any resolution passed under the postal ballot;
 - (iii) the notice of postal ballot must contain the text of the resolution and the date for closing of the ballot and may contain any other information the Responsible Entity considers appropriate;
 - (iv) each ballot paper must specify the name of the person entitled to vote;
 - (v) a postal ballot is only valid if the ballot paper is duly completed and:

3 Timing of notice

The Proposing Transferor is not required to give a Transfer Notice to the Responsible Entity before the Proposing Transferor has exchanged a securities sale agreement in relation to the Sale Securities provided that:

- (a) a Transfer Notice is given within two Business Days of any exchange of a securities sale agreement; and
- (b) the relevant securities sale agreement is subject to, and conditional on, the APT Manager not accepting an offer under this schedule 2.

4 Irrevocable offer
