# Tamboran Resources Corporation (ASX: TBN) – Admission and Quotation

## **Description**

On 2 July 2021, Tamboran Resources Limited (ASX: TBN) an Australian incorporated entity was admitted to the official list of ASX.

On 12 October 2023, Tamboran Resources Limited announced its intention to re-domicile from Australia to the United States. It proposes to do this by way of a scheme of arrangement under Part 5.1 of the Corporations Act 2001 ('Scheme'). Under the Scheme, by order of the Federal Court of Australia ('Court'), Tamboran Resources Corporation a newly incorporated entity in Delaware, United States, will acquire 100% of the issued share capital in Tamboran Resources Limited, and Tamboran Resources Corporation will become the new holding company of Tamboran Resources Limited and each of its wholly owned subsidiaries.

Existing Tamboran Resources Limited shareholders (except for any ineligible foreign holders) at the Scheme record date, will be entitled to one Taboran Resources Corporation Chess Depository Interest (CDI) for each share in Tamboran Resources Limited they hold (i.e. on 1:1 basis). Each CDI confers a beneficial interest in 1/200<sup>th</sup> of a Tamboran Resources Corporation share of common stock. Further details are set out in the Scheme Booklet dated 27 October 2023.

On 6 December 2023, Tamboran Resources Limited announced that the Court has made orders approving the Scheme and that the effective date of the Scheme is 7 December 2023.

On 6 December 2023, Tamboran Resources Limited confirmed that the conditions of the Scheme have been satisfied.

Tamboran Resources Corporation will be admitted to the official list of ASX on Friday, 8 December 2023.

It is anticipated that the Tamboran Resources Corporation CDIs representing fully paid shares of common stock at a ratio of 200:1 (i.e. 200 CDIs confer a beneficial interest in one share of common stock) will commence quotation at approximately 10:09 am (AEDT) on Friday, 8 December 2023 on a <u>deferred settlement basis</u> <u>under the temporary code TBNDA</u>. An indicative timetable is included on the final page of this announcement.

No funds were raised by Tamboran Resources Corporation in conjunction with its listing on ASX.
