Distribution Reinvestment Plan

Transurban announces that security holders representing 5.60% of issued capital have elected to participate in the Distribution Reinvestment Plan (DRP) in operation for the distribution of 30.0 cents per stapled security for the six months ended 31 December 2023.

The DRP issue price is \$13.5643 per stapled security.

The stapled securities issued under the DRP will rank equally with existing stapled securities, and will be issued on the distribution payment date, 13 February 2024.
