<p>The company has loan facilities in place with banks in Italy, Brazil and USA with interest rates varying from 4% to 12%. The majority of these loans are unsecured.</p> <p>The company has unsecured bank guarantees in place in Italy.</p> <p>On 29 July 2020, the Group entered into a loan agreement with an affiliate of Upwell LLC to provide an initial \$20 million finance facility (the "Facility"). On 10 December 2021 the facility was increased to \$30.3 million. The Facility was made available to finance recurring revenue projects (i.e BOO projects) and for working capital needs. In 2023 the Company repaid \$13.1 million of its debt to Upwell LLC.</p>
