- (6) The voting shares of a company constitute one class unless divided into separate classes.
- (7) Give details, if appropriate, of the present association and any change in that association since the last substantial holding notice.

### ANNEXURE A

The following holdings in Newmark Property REIT which were, in good faith, included in the initial Form 603 were subsequently found to have already accepted the BWP Trust offer. Accordingly, they should not have been included in the notice. No cash consideration was involved in any of the associated holdings.

With the reduction of the number of securities brought about by the removal of the 1,087,298 securities, the substantial shareholder notice dated 19 February is nullified.
