



## ARC SPP OFFER OPENS

**22 March 2024:** ARC Funds Limited (ASX:ARC) ("**ARC**" or "**the Company**") is pleased to announce the opening of the ARC Share Purchase Plan ("**SPP**") Offer.

ARC announced on 11 March 2024 that it would be undertaking a SPP. The SPP is now open to eligible ARC shareholders in Australia and New Zealand to apply for up to \$30,000 of new fully paid ordinary shares in ARC ("**SPP Shares**") without incurring brokerage or other transaction costs.

The SPP follows the successful completion of approximately \$865,000 (before costs) placement of approximately 7.5 million new fully paid ordinary shares in the Company ("**Shares**") to sophisticated and professional investors on 20 March 2024 ("**Placement**").

Both the Placement and the SPP are being issued at a price of \$0.115 per new Share ("**Offer Price**"). The Offer Price represents a:

- 2% discount to the 5-day VWAP of \$0.1174 per share as at 11 March 2024; and
- 22.8% discount to the 15-day VWAP of \$0.149 per share as at 11 March 2024.

On behalf of the directors of ARC Funds Limited ACN 060 094 742 (**ARC**), I am pleased to offer you the opportunity to participate in a share purchase plan (**SPP**), which allows each Eligible Shareholder to subscribe for up to \$30,000 of new Shares in ARC (**SPP Shares**) without incurring brokerage or other transaction costs.

The SPP aims to raise up to \$300,000 and is not underwritten. ARC may decide to accept applications (in whole or in part) that result in the SPP raising less than \$300,000, in its absolute discretion. Should any scale back be necessary, any scale back arrangements will be made on a pro rata basis to existing shareholdings as at the Record Date (as defined below) at the discretion of the board. The SPP follows ARC's successful completion of its institutional placement as announced to the ASX on 11 March 2024, which raised \$865,000 (**Placement**) before costs.

The SPP Shares are being offered at the Issue Price of \$0.115 per SPP Share, being the same price paid by investors under the Placement.

The SPP, together with the completed Placement, will provide working capital to support ARC's existing growth strategy in the funds management industry and adjacent service offerings.

Further details about the Placement and SPP are included in ARC's ASX announcement on 11 March 2024, which we encourage you to read.

## Participation in the SPP

Participation in the SPP is voluntary and open to all Eligible Shareholders, being registered holders of Shares (**Shareholders**) as at 7.00pm (Melbourne time) on Friday 8 March 2024 (**Record Date**) and whose address on the Register is in Australia or New Zealand. The SPP is also being extended to Eligible Shareholders who are Custodians or nominees to participate in the SPP on behalf of certain Eligible Beneficiaries on the terms and conditions set out in this booklet (**Booklet**).

Shareholders in the United States are not eligible to participate in the SPP. Similarly, Shareholders (including Custodians and nominees) who hold Shares on behalf of persons in the United States, or are acting for the account or benefit of persons in the United States, are not eligible to participate in the SPP on behalf of those persons.

This Booklet does not constitute a prospectus or product disclosure statement, and has not been lodged with ASIC. The issue of a prospectus or product disclosure statement is not required for the purpose of the SPP Offer. You must rely on your own knowledge of ARC, previous disclosure made by ARC to ASX and it is recommended that you consult with your stockbroker, solicitor, accountant or other professional adviser when deciding whether or not to participate in the SPP Offer.

If you participate in the SPP by completing the Application Form or by making a payment by BPAY or EFT, you are accepting the risk that the market price of Shares may change between the Record Date, the date on which you complete the Application Form or make a payment by BPAY or EFT and the Issue Date. - (c) Participation in the SPP is voluntary. If you choose not to participate in the SPP, your right to participate lapses at the Closing Date, being 5.00pm (Melbourne time) on Friday 5 April 2024 (or such other date and time as ARC determines, in its absolute discretion). ARC reserves the right, but is not obligated, to accept applications for SPP Shares that are received after the Closing Date.
- (d) The SPP Offer is non-transferable and, therefore, Eligible Shareholders cannot transfer their right to apply for SPP Shares to a third party.

- (d) Eligible Shareholders who receive more than one offer under the SPP (for example, because they hold Shares in more than one capacity or in different registered holdings) may apply on different Application Forms for SPP Shares but may not apply for SPP Shares with an aggregate value of more than \$30,000 across all shareholdings in those different capacities.
- (e) If you wish to subscribe for SPP Shares as a Custodian or nominee for one or more Eligible Beneficiaries, you must also complete and submit an additional Custodian Certificate that contains further certifications and details (required under the terms of *ASIC Corporations (Share and Interest Purchase Plans) Instrument 2019/547*) before your application will be accepted. - (f) ARC may accept or reject your application for SPP Shares in whole or in part in its discretion including, without limitation, if:
- (1) your application does not comply with these terms and conditions;
  - (2) it appears you are not an Eligible Shareholder (subject to compliance with any applicable ASIC requirements);
  - (3) your Application payment is not received by the Closing Date, being 5.00pm (Melbourne time) on Friday 5 April 2024 (or such other date as ARC determines, in its absolute discretion);
  - (4) it appears that you are applying to purchase more than \$30,000 of SPP Shares in aggregate (including as a result of Shares you hold directly, jointly or through a custodian or nominee arrangement) or your application is not for an amount that is a multiple of \$1,000, starting at \$1,000 up to a maximum of \$30,000;

#### **4.6 Number of SPP Shares to be issued**

Any interest received on application money may be retained by ARC whether or not SPP Shares are issued under the SPP.

#### **4.8 Issue of SPP Shares**

- (a) SPP Shares will be issued on the Issue Date.
- (b) SPP Shares will rank equally with existing Shares and have the same voting rights, dividend rights and other entitlements as existing Shares as at the Issue Date.



- (c) ARC will apply to ASX for the quotation of SPP Shares. It is anticipated that SPP Shares will be quoted and commence trading on ASX on or around Monday 15 April 2024.
- (d) The Registry or CHESS will send you a holding statement, confirming the issue of SPP Shares to you, which is anticipated to be sent on or around Friday 19 April 2024.

#### **4.9 Shareholders outside Australia and New Zealand**

- (a) The laws of some jurisdictions prohibit or make impracticable participation in the SPP by certain overseas Shareholders. Shareholders who do not have a registered address in Australia or New Zealand will not be able to participate in the SPP. The SPP does not constitute an offer of Shares for sale or issue in any other jurisdiction.
- (b) The SPP Shares are not being offered or sold to the public within New Zealand other than to existing Shareholders of ARC at the Record Date with registered addresses in New Zealand to whom the offer of SPP Shares is being made in reliance on the *Financial Markets Conduct Act 2013 (New Zealand)* and the *Financial Markets Conduct (Incidental Offers) Exemption Notice 2021 (New Zealand)*.
- (c) This Booklet has not been registered, filed with or approved by any New Zealand regulatory authority. This Booklet is not a product disclosure statement under New Zealand law and is not required to, and may not, contain all the information that a product disclosure statement under New Zealand law is required to contain.
- (d) Shareholders in the United States are not eligible to participate in the SPP. Similarly, Shareholders (including Custodians and nominees) who hold Shares on behalf of persons in the United States, or are acting for the account or benefit of persons in the United States, are not eligible to participate in the SPP on behalf of those persons.

#### **4.10 Acknowledgements**

By completing an Application Form and making a payment via BPAY or EFT, you:

- (c) agree that your application will be irrevocable and unconditional (that is, it cannot be withdrawn by you under any circumstances);

- (e) acknowledge that no interest will be paid on any application monies held pending the issue of SPP Shares or subsequently refunded to you for any reason;
- (f) acknowledge that ARC and its officers and agents, are not liable for any consequences of the exercise or non-exercise of its discretions referred to in these terms and conditions;

## 6 Key Risks

An investment in ARC Shares is subject to investment and other known and unknown risks, including possible loss of income and principal invested.

Set out below are some of the key risks that have been identified as potentially affecting the performance and value of the SPP Shares and the ability of the Company to potentially pay dividends in the future. The past performance of the Company is not necessarily representative of the future performance of the Company or the value of the SPP Shares.

### 6.1 Risk factors associated with owning ARC Shares

The business activities of ARC are subject to risks. These risks include those which apply generally to investments in equity markets, and those which apply specifically to ARC's business. Some of the specific risks may be mitigated through the use of safeguards and contingency plans. However many risks are outside the control of ARC and its directors and cannot be mitigated.

Shareholders should consider that the investment in ARC is speculative and should consult their professional advisers before deciding whether to apply for the SPP Shares.

The future performance of ARC and the future investment performance of ARC Shares may be influenced by a range of factors, many of which are outside the control of ARC or of any manager of any assets of ARC. The future value of ARC's assets and the price at which ARC Shares trade on the ASX may be influenced by any one or more of these factors. The following matters and summary of material risk factors given below should be carefully considered in evaluating the prospects of ARC.

### 6.2 Further funding requirements

Although the Directors believe that, on completion of the SPP Offer, ARC will have sufficient working capital to carry out its stated business objectives, there can be no assurance that such objectives can be met without further financing or, if further financing is necessary, that it can be obtained on favourable terms or at all. If additional funds are raised by issuing equity securities, this may result in dilution of some or all of the existing Shareholders of ARC.

### 6.3 Long-term investments

Shareholders are strongly advised to regard an investment in ARC as a long-term proposition and to be aware that, as with any equity investment, substantial fluctuations in the value of their investment may occur. ARC cannot guarantee its future earnings and cannot provide a guaranteed level of return to investors.

### 6.4 Investment risk

There are several types of investment risk that may affect an investment in ARC, including a decline in the market price of the Shares (the initial capital value may decrease, especially if investing for the short term), the amount received as income may vary over time or the value of an investment may not keep pace with inflation. This includes the possibility that ARC may not be able to achieve the medium to long-term capital growth objectives.



## 6.5 Economic conditions

The operating and financial performance of ARC is influenced by a variety of general economic and business conditions including the level of inflation, international share markets, interest rates and exchange rates and government fiscal, monetary and regulatory policies. A prolonged deterioration in general economic conditions, including an increase in interest rates or a decrease in consumer and business demand, could be expected to have a material adverse impact on ARC's business or financial situation.

## 6.6 Force majeure events

Events may occur within or outside Australia that could impact upon global, Australian or other local economies relevant to ARC's financial performance or operations. These events include but are not limited to acts of terrorism, an outbreak of international hostilities, fires, floods, earthquakes, labour strikes, civil wars, natural disasters, outbreaks of disease or other man-made or natural events or occurrences that can have an adverse effect on ARC. ARC has only a limited ability to insure against some of these risks.

## 6.7 Specific risk factors

The key issues impacting the success of the business undertaken by ARC are:

- (a) the success and profitability of ARC depends, in part, upon the ability of the directors to invest in well-managed companies which have the ability to increase in value over time. In many cases, the directors and management of ARC will be unlikely to be in a position to influence materially the decisions and strategies made and adopted by the management of those companies;
- (b) ARC may make investments:
  - (1) in companies or other entities with small market capitalisations. In general, trading in securities in such entities has more limited liquidity than larger companies and so has the potential for greater volatility. Accordingly, the returns that may be generated by ARC are likely to also be subject to that greater volatility;
  - (2) in securities which have limited or no voting entitlements. In general, such securities trade at a large discount to intrinsic value, but there is no guarantee that ARC will be able to exert adequate influence to change the voting rights of such securities, which may remain trading at high discounts. In addition, trading in such securities tends to have more limited liquidity than fully voting securities;
  - (3) in securities not listed on an organised stock exchange, where financial performance is heavily uninfluenced by managerial expertise, and where no ready market for the sale or liquidation of such investments exists. Accordingly, these investments carry substantially larger risks of financial loss;

The financial performance of such investments may be heavily governed by overall conditions in financial, commodity and other markets, over which neither ARC nor the investee company has any control. As a consequence, the performance of investments held by ARC may exaggerate movements in overall financial, commodity or other markets in either a positive or negative manner;

- (c) the price of investments that ARC may purchase can fall as well as rise;

- (d) the course of acquiring or selling investments, ARC is required to deal with counterparties who may be incapable of settling transactions due to financial stress. ARC seeks to mitigate this risk by dealing with brokers and counterparties of good standing;
- (e) the operations and activities of ARC and the entities in which its invests may be subject to State and Federal laws and regulations on a country by country basis concerning the environment. Certain projects and operations conducted by entities in which ARC invests may have an impact on the environment, particularly if these relate to development. ARC conducts its activities in compliance with all environmental laws and is not aware of any non-compliance at this point in time;
- (f) any international companies, entities or securities in which ARC invests or international transactions in which ARC or any such investees may engage may be subject to the risks associated with operating in a foreign country. These risks may include economic, social or political instability or change, hyperinflation, currency non-convertibility or instability and changes of law affecting foreign ownership, government participation, taxation, working conditions, rates of exchange, exploration licensing, repatriation of income or return of capital, environmental protection, mine safety, labour relations as well as government control over properties or government regulations that require the employment of local staff or contractors or require other benefits to be provided to local residents.

Without limiting the above matters:

- (g) shareholders are strongly advised to regard any investments in ARC as a long term proposition and to be aware that, as with any equity investment, substantial fluctuations in the value of their investment may occur over time;
- (h) operating costs for ARC as a proportion of total assets are affected by the level of total assets of ARC.
