## 3D.1 Any other information the entity wishes to notify to ASX about the buy-back

AMP intends to buyback up to \$295m ordinary shares on-market. At the 2023 AGM, shareholders approved exceeding the 10/12 limit to buyback up to 350m shares on-market to 31 March 2024. The buyback will initially be conducted within that approval.

From 1 April 2024, it will be within the 10/12 limit. From 12 April 2024, the buyback may exceed that limit per the 2024 AGM shareholder approval. AMP will only buyback shares at such times and in such circumstances as it considers appropriate.
