Activeport and Radian Arc to accelerate cloud gaming revenue growth following successful close of Radian Arc's B Round.

Activeport Group Ltd ("Activeport" or "the Company" or "Group"), (ASX:ATV) is pleased to announce that the condition precedent for the working capital agreement announced 30 April 2024 has been met. Activeport's GPU Orchestration partner, Radian Arc Limited (Radian Arc) has raised USD \$9M with the option to raise up to USD \$15M to grow their Cloud Gaming and AI service offerings. ActivePort participated in the B round by converting USD \$500K of outstanding receivables due from Radian Arc to 2,126,594 series B preference shares in Radian Arc.

Highlights

- Radian Arc, the GPU orchestration partner of Activeport, has completed its B-round, providing Radian Arc with minimum US\$9m and up to US\$15m of capital.
- Capital will accelerate the global roll-out of Radian Arc's cloud gaming platform incorporating Activeport's orchestration software.
- Activeport currently earns recurring revenue of A\$1M and growing by licensing software to Radian Arc.
- Activeport expects revenue from its GPU orchestration software to accelerate as Radian Arc expands its services beyond cloud gaming to include AI solution hosting.

Activeport is working closely with Radian Arc and their partners to create GPU-centric orchestration solutions used for cloud gaming and AI. Activeport currently earns AUD \$1M a year of recurring revenue from its GPU orchestration software via Radian Arc and anticipates revenue growth to accelerate as more cloud gaming sites are brought online and new AI applications are deployed on Radian Arc's platform.

Activeport and Radian Arc

Like music and video before, PC and console (Xbox, PlayStation) games are rapidly moving to the cloud. Radian Arc, with its content partner Blacknut (www.blacknut.com) and BYO-game (BYOG) partner OnePlay (www.oneplay.in) is at the forefront of that migration. The carriers committed to deploying Radian Arc's platform, incorporating Activeport's software have a combined subscriber base in excess of 2.5 billion, making it one of the largest potential channels to market available for game publishers and AI application developers.

Activeport and Radian Arc work closely with key technology providers to optimise Activeport's software performance on GPU's, CPU's and network encoder cards. The same technology used to deliver cloud gaming at scale can also host AI applications and as this new industry evolves, revenue should receive an extra boost as telecommunications carrier's require more GPU and CPU power to deliver AI-driven solutions to their end-users.


Activeport Paths to Market

Radian Arc is key partner for one of Activeport's three primary paths to market:



 that use Activeport software to automate delivery of network services and offer a self-service cloud
 experience to their customers; and



3. Activeport offers a Software-as-a-Service platform for ISP's and network service providers to offer an edge-to-cloud network orchestration solution to their customers.



The partnership with Radian Arc has seeded more than 70 telecommunications carriers with Activeport's orchestration software over the past two years, where it is used to deliver cloud gaming solutions today and will also deliver AI applications into the future.
