## ASX Group Monthly Activity Report – May 2024

### Listings and Capital Raisings

- In May 2024, total new capital quoted was \$4.6 billion, compared to \$2.8 billion in the previous corresponding period (pcp).
- Total net new capital quoted was negative \$2.6 billion, an improvement of 71% on the pcp. On a May YTD basis total net new capital quoted was \$22.5 billion, up 103% on the pcp.

## Trading – Cash Markets (including equities, interest rate and ETP trades)

- In May 2024, the average daily number of trades was up 32% on the pcp. The average daily value traded on-market of \$5.415 billion was up 4% on the pcp.
- Volatility (as measured by the average daily movement in the All Ordinaries Index) was 0.6% in May, compared to 0.5% in the pcp.
- Future volatility (as measured by the S&P/ASX 200 VIX) in May was an average of 11.4, down 8% on pcp.

- In May 2024, average daily futures volume was up 28% on the pcp and average daily options volume were 788, compared to 2,028 in the pcp. Total average daily futures and options on futures volumes were up 28% on the pcp.
