Swoop Acquires Residential Fibre Infrastructure in Regional WA

Transaction Highlights include:

- Swoop has completed the acquisition of the conduit and fibre assets in the Seacrest Estate, near Geraldton WA.
- The infrastructure is connected to approximately 900 existing homes and expected to deliver an increase of \$1.2m Revenue over the next 3 years
- This transaction was funded from existing cash reserves, with significant firepower remaining to explore other transactions and deliver growth in our key products.

As part of its ongoing commitment to improving the connectivity and service in regional Australia, Swoop has completed the transaction to acquire the conduit and fibre assets in an existing housing estate located near Geraldton Western Australia in an all-cash offer funded from existing cash reserves.

Commenting on the transaction, Swoop Chief Executive Officer Alex West said "This is an exciting time for Swoop as we continue to focus on our residential infrastructure to ensure that we are delighting our customers, we are now in a position to offer high speed fibre based solutions as an alternative to the incumbent players."

This acquisition is the start of our long-term strategy to ensure that we deliver returns on high margin fibre products. And we will continue to look at other opportunities in this space, as well as focusing on building our own Swoop Infrastructure brand as an alternative for developers looking for greater service and value from their projects."
