# Contract expands commercial rollout of XV Technology® in Australia

Jones Radiology is a doctor owned and operated medical imaging practice offering a comprehensive range of diagnostic and interventional radiology services. With 29 clinics across Adelaide, regional South Australia and Alice Springs, the contract with Jones Radiology expands the network of diagnostic imaging sites that provide patients and their referring doctors with 4DMedical's revolutionary XV Technology<sup>®</sup>–enabled ventilation reports.

The contract follows a successful pilot of CT LVAS<sup>™</sup> at three of Jones Radiology's Adelaide clinics where scans were referred from both specialists and GPs.

The partners envisage that most referrals will be for the Company's CT LVAS<sup>™</sup> product, which utilises widely available Computed Tomography (CT) imaging infrastructure, but the contract also facilitates access to 4DMedical's XV LVAS<sup>®</sup> product via fluoroscopy as required by referring doctors. Ventilation reports will be delivered and billed on a Software-as-a-Service (SaaS) model on terms in line with those of the Company's other partners.

Both parties are committed to working together to promote and market the services to referring clinicians to mutual benefit.
