Mackay Potash Project Process Engineering Update

Highlights

- Flotation testwork successfully achieved greater than 90% potassium recovery at greater than 90% schoenite grade, focusing on lower grade feed salts that are expected during initial ramp-up of operations
- This represents a significant milestone as flotation is the primary separation step within the proposed process flowsheet and can significantly impact process plant performance
- Testwork was conducted in partnership with leading equipment vendors FLSmidth and Veolia
- Planned testwork for the remainder of 2024 includes optimising the leach and SOP crystallisation stages

Agrimin Limited (ASX: AMN) (“Agrimin” or “the Company”) is pleased to report successful flotation results and provide an update in relation to ongoing process testwork for the Mackay Potash Project (“the Project”). The results reported in this announcement relate to flotation testwork that was completed in partnership with FLSmidth Inc. (“FLSmidth”) and Veolia Water Technologies Inc. (USA) (“Veolia”).

Flotation testwork was performed at Veolia’s facility in Plainfield, USA and utilised FLSmidth’s flotation test unit and expertise. The testwork aimed to evaluate a range of flotation variables including collector selection, collector dose rate, collector application, collector conditioning time, mixing dynamics (conditioning and flotation), chemical behaviour, process temperature and flotation kinetics.

Debbie Morrow, Managing Director & CEO of Agrimin commented: “Successful flotation results at a range of operating conditions are an excellent result as flotation has been a key challenge for the SOP industry in Western Australia.

“Our findings have demonstrated that the conversion step of the process is critical for producing the suitable salts for successful flotation.

“The next phase of testwork will challenge these results further to better understand the bounds of the flotation unit.

"In the second half of the year we will continue to work with leading equipment vendors Veolia and FLSmidth to finalise testwork and then move to focus on the downstream schoenite leach and SOP crystallisation stages of the flowsheet."

Graeme Ditri, Process Manager, Agrimin commented: *"We are pleased with the flotation results achieved in collaboration with Veolia and FLSmidth undertaken at the Veolia test facility in the USA. Collaboration with leading equipment vendors to co-design and undertake the laboratory work strengthen the results and our understanding of the range of conditions required to advance the plant design for commercial scale."*

"The repeatability of both the recent conversion results and now flotation results is highly encouraging."

"We look forward to finalising the float testwork and progressing efforts to refine schoenite leach and SOP crystallisation stages."

Flotation Testwork Discussion

The Company, as part of front end engineering design ("FEED"), has been progressing thorough process testwork using samples harvested from the Mackay Potash Project. In conjunction with recent industry learnings, and with the support of leading equipment vendors, the results are being used to finalise the process design and equipment selection.

Flotation is a critical step required to separate the potassium bearing minerals from the waste salts that are harvested from the evaporation ponds (refer Figure 1).

In previous conversion testwork (announced to the ASX on 1 March 2024) it was found that temperature control to approximately 15 degrees celsius was required to ensure that schoenite was produced in the conversion stage. Without temperature control, it is probable that harvest salts will convert to leonite which is not amenable to direct flotation. Having successfully tested the paramaters required for conversion stage, ongoing testwork has focussed on flotation.

Utilising potash harvest salts from the Lake Mackay trench and pond trial, schoenite feed material was produced by conversion with Veolia. The focus being on lower potassium grades which are expected to occur during the initial ramp-up phase of operations.

A total of 23 open cycle tests were conducted which considered a range of conditions for flotation. Repeatable results were achieved under preferred conditions, consistent with the Definitive Feasibility Study (announced to the ASX on 21 July 2020) with design values of 90% potassium recovery and 90% schoenite grade.

A selection of test results are presented in Table 1 and Figure 2, which show repeatable recoveries and grades above 90%. These results provide high confidence in reaching a commercial solution for SOP production. Further testwork is planned to optimise the operating ranges and limits for the Leach and SOP Crystallisation stages, including the influence of recycle streams and feed variation.

Figure 1. Simplified Process Flowsheet

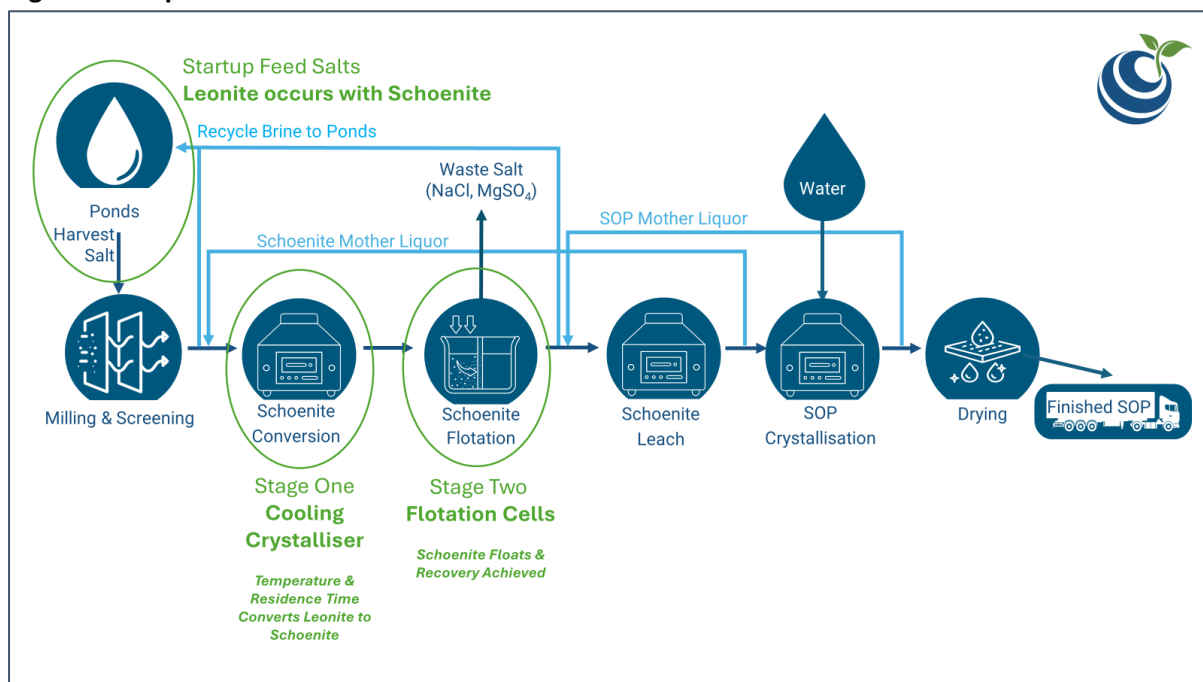
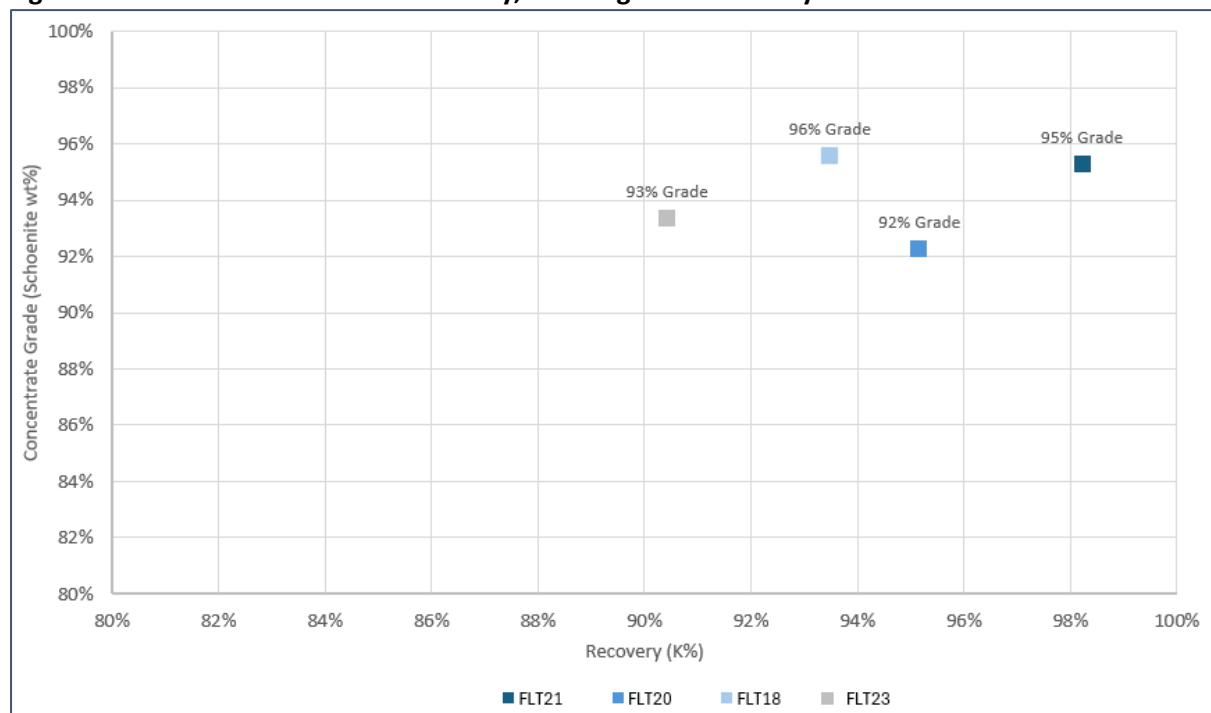
