# Alliance Aviation Services Limited ("Alliance") (ASX: AQZ)

## **BHP Nickel West Operations**

Yesterday Alliance was advised that BHP's Nickel West operations would move from full production to care and maintenance by December 2024.

Currently Alliance operates 24 round trips per week for BHP Nickel West between Perth and Mt Keith and Perth and Leinster.

Alliance anticipates that the number of flights will reduce over time, to a level sufficient for the care and maintenance staff to be rotated in the normal fashion.

Alliance's services for BHP Nickel West occupy two Fokker 100 aircraft, effectively full time, operating 3,140 hours per annum in aggregate.

During FY24 those hours represented 3% of total company flight hours and with the growth in other areas of the business forecast for FY25 hours would have fallen to 2.15% of total flying.

Alliance estimates a full year impact of approximately \$5million at the EBITDA level for FY26 and given the service reduction are anticipated to commence in October this year the impact for FY25 will be approximately \$3-4million at the EBITDA level.

However, given the nature of the company's operation, the surplus capacity will be reallocated to existing and new customers in Western Australia and Queensland, so at this time, this situation will have a minimal net impact on the company's earnings going forward.

In the meantime, Alliance will work with BHP Nickel West in a flexible and supportive manner as would be expected from the long-term relationship both companies have enjoyed since 2006.

Alliance will present its annual results, post market closure on 14<sup>th</sup> August 2024 and provide a further update on BHP Nickel West developments at that time.

Alliance is locally owned with the majority of the Company's shareholders located in Australia and New Zealand.
