QUARTERLY ACTIVITIES REPORT

Quarter ended 30 June 2024

MELBOURNE, AUSTRALIA (31 July 2024): Hexima Limited (ASX:HXL) (**Hexima** or **Company**) today releases its Appendix 4C and sets out below its quarterly activities report for the quarter ended 30 June 2024.

During the quarter, Hexima continued to work on a proposed acquisition of 100% of the issued capital of Real Thing Entertainment Pty Ltd, the developer of an artificial intelligence platform that is marketed internationally. Full details of the proposed transaction were announced to the market on 24 July 2024.

Financial update

The company closed the quarter with \$2.2m in cash balances.

During the quarter \$318k net cash was used in operating activities. This comprised interest income and tax refund received of \$16k, and net operating expenditures of \$334k, which were largely ongoing compliance costs and professional fees and other costs associated with the proposed acquisition outlined above.

In accordance with Listing Rule 4.7C disclosure, payments made to related parties and their associates included in item 6.1 of the Appendix 4C represented payments for directors' fees and remuneration in the normal course of business at commercial rates, excluding reimbursements of out-of-pocket expenses.
