VIVA LEISURE COMPLETES FINAL WESTERN AUSTRALIAN ACQUISITION

Viva Leisure Limited (ASX: VVA) ("Viva Leisure" or "Viva" or "Company") is pleased to confirm the early completion of the final locations of the recently announced Western Australian acquisitions.

Key Highlights:

- **Acquisitions:** The final five locations as part of the Western Australian strategic acquisitions have been completed, adding approximately 10,000 corporate members.
- **Corporate Members:** Now over 220,000, an increase of approximately 38,000 members or 21% since 30 June 2023.
- **Network Members:** Now over 395,000, an increase of approximately 53,000 members or 15% since 30 June 2023.
- **Corporate Locations:** Now at 185, up from 171 from 30 June 2023.
- **Network Locations:** 361, up from 346 in FY2023.

Western Australian Acquisitions

Viva Leisure confirms the early completion of the final five locations as part of the strategic acquisitions announced on 6 June 2024. Originally scheduled for completion before the end of August 2024, the early completion will positively impact the FY2025 results.

Viva will now commence the integration and conversion process to the Club Lime brand.

Upon completion of the conversion, the Viva-owned Club Lime brand will further cement its position as Australia's largest non-franchised health club brand, expanding to 123 Club Lime locations. This remarkable growth underscores Viva Leisure's journey from just 27 Club Lime operating locations at IPO in June 2019.

Harry Konstantinou, CEO and Managing Director of Viva Leisure Limited, said:

"We are really pleased to successfully complete our strategic Western Australian acquisitions ahead of schedule, significantly enhancing our presence and adding to our growing Viva Leisure community. The acquisitions marks an exciting milestone, reflecting our commitment to expanding our footprint and delivering exceptional fitness experiences to more Australians."

"With the integration and conversion of these new locations to the Club Lime brand, we are set to strengthen our position as the leading non-franchised health club brand in Australia. This growth journey from our IPO in 2019 underscores the dedication and hard work of our entire team, and we are excited about the continued opportunities ahead for our members, our 200 new team members and our stakeholders."
