Change of interests of Robert Henry Richard Adamson

Chrysos Corporation Ltd (ASX:C79) (“Chrysos” or the “Company”) attaches to this announcement, in order:

- (a) an Appendix 3Y for Robert Henry Richard Adamson; and
- (b) a Form 605 (Notice of ceasing to be a substantial holder) for Robert Henry Richard Adamson dated today.

In connection with these attachments, Chrysos seeks to clarify the basis on which Mr Adamson’s interests in the securities of the Company has changed. Namely, the change in Mr Adamson’s interests has arisen due to the voluntary liquidation of Alchemy Portfolio Holdings Pty Ltd and Alchemy Securities Pty Ltd (“Alchemy”) by the members of Alchemy and has not otherwise arisen due to any disposal of shares in Chrysos by Mr Adamson, or by any entity of which he has control.

Alchemy was an entity formed by Mr Adamson alongside current and former shareholders of RFC Ambrian Group Limited for the purpose of holding investment in two ventures co-founded by Alchemy and Australia’s national science agency, CSIRO: Chrysos Corporation and NextOre Limited (“NextOre”). The Board and shareholders of Alchemy elected to liquidate Alchemy, and distribute any shares held to Alchemy’s shareholders for the purposes of enabling them to make their own investment decisions regarding their holdings in Chrysos and NextOre.

As flagged above, no shares in Chrysos have been sold by Mr Adamson nor by any entity which he controls. Consequently, Mr Adamson’s beneficial interest in the Company’s shares has not changed.
