

Updated Top 20 Shareholder List

Indiana Resources Limited (**ASX: IDA**) (“**Indiana**” or the “**Company**”) provides the attached updated top 20 shareholder list of listed securities in the Company.

Following the recent trading halt, suspension and resumption of normal trading activities on 29 July 2024, a total of 109.2M shares in the Company have traded.
