**Corporate Governance Statement**

This statement outlines the Corporate Governance framework and practices adopted by the Board of Directors of Harris Technology Group Limited (**HT8**) and in place for the financial year ended 30 June 2024, by reference to the ASX Corporate Governance Council’s Corporate Governance Principles and Recommendations (4th Edition) (**the Recommendations**). The Statement was approved by the Board on 28 August 2024.

The Board and Senior Management of HT8 are committed to acting responsibly, ethically and with high standards of integrity as the Company strives to create shareholder value. HT8 is committed to implementing the highest standards of corporate governance appropriate for a company of its size and operations.

The Board considers and applies the Recommendations taking into account the circumstances of the Company. Where the Company’s practices depart from a Recommendation, this Statement identifies the area of divergence and reasons for it, or any alternative practices adopted by the Company.

The policy has been set out to ensure that the performance of Directors, key executives and staff reflect each person's accountabilities, duties and their level of performance, and to ensure that remuneration is competitive in attracting, motivating and retaining staff of the highest quality. A program of regular performance appraisals and objective setting for key executives and staff is in place. These annual reviews take into account individual and company performance, market movements and expert advice.</p>

If the Chairman of the Board intends to trade in the Company shares, the Chairman of the Board must give prior notice to the whole Board. The details of the share trading must be given to the Company Secretary who must lodge such details of such changes in with the ASX.</p> <p>Senior executives must give prior notice to the Chief Executive Officer, while other officers must notify the Company Secretary, before trading in the Company shares and details of all such transactions must be given, in writing, to the Company Secretary within 7 business days.</p> <p>Any changes in substantial shareholding of the Directors, senior executives or other officers must be reported to the ASX within 2 business days of such trading.</p>
