The Long Term Performance Rights have been issued in 3 equal tranches with performance conditions the same as previous rights issued with the addition of a further time hurdle which will only allow up to a third of the rights issued to be exercised after 24 months, with the remainder only exercisable after 36 months, subject to all other vesting conditions being met. The Share Price Hurdles attached to the three equal tranches of new Performance Rights are AUD 0.22, AUD 0.24 and AUD 0.26, with the volume of rights and/or hurdles to be adjusted (as applicable) by the Board (at its discretion) to account for any dividends, returns of capital, share consolidation or other re-organisation of capital of the Company.

In addition to the above issuance, an additional 7,500,000 Long Term Performance Rights are to be issued to Mr Richard Beament (CEO and Managing Director of the Company) in three equal tranches that are subject to shareholder approval at the 2024 AGM to be held on 20 November 2024 in accordance with ASX Listing Rule 10.14. Under the terms of the grant of Long Term Performance Rights, if shareholder approval is not obtained for the grant of Long Term Performance Rights, an equivalent benefit may be delivered to Richard in the form of cash.
