## 360 Capital Group (ASX:TGP)

## Underwrites \$14.6 million senior loan facility in 360 Capital Private Credit Fund

360 Capital Group (ASX:TGP) ("**Group**") is pleased to announce that it has underwritten a new \$14.6 million senior loan facility within 360 Capital Private Credit Fund ("PCF").

The loan was funded through proceeds from the selldown of the previous \$26.2 million loan set in July 2024.

The loan is secured by 19 individual registered first mortgages over 19 completed 3 and 4 bedroom homes located in the growth corridor of north-western Sydney. The borrower has also provided additional security including, but not limited to, personal and corporate guarantees and general security agreements.

The loan term is 12 months, at an interest rate margin of 6.6% above 3-month BBSW (currently 'all in' rate circa 11.1% p.a.) with a floor of 11.0% if interest rates fall. The loan has a LVR covenant of 70% to be reduced to 65% before any cash proceeds from sales are released to the borrower.

This investment follows the \$26.2 million loan underwritten in July 2024 which has been progressively repaid to the Group by a combination of sell down through PCF's investor network, home sales and sell down to 360 Capital Mortgage REIT (ASX:TCF) ensuring TCF remains fully invested, maximising TCF unitholders returns.
