

## Entry into Manufacturing Agreement with Nutura Organic Ltd

Australian Dairy Nutritionals Limited (**AHF** or the **Group**) is pleased to announce that it has entered into a manufacturing agreement with Australian-based company Nutura Organic Ltd (Nutura) to manufacture intermediate and fortified milk formula base powder.

Nutura is a Melbourne-based company which produces a range of nutrition products made exclusively from Australian sourced milk sold in Australia, Vietnam and China. The manufacturing agreement has an initial term of 1 year with an option to extend for a further 2 year term.

Nutura is expanding rapidly into new markets and AHF with its vertically integrated organic farms and manufacturing capability will play a key role in providing high quality base powder for Nutura..

AHF does not consider that the manufacturing agreement with Nutura will be immediately financially material, as sales volumes are not yet known. However, this agreement establishes a key strategic partner for the business. There are no other material conditions that need to be satisfied before the parties become legally bound to proceed with the terms of the manufacturing agreement. There is no other material information relevant to assessing the impact of the manufacturing agreement on the price or value of the Company's securities.
