The vesting of Restricted Rights detailed in this Appendix 3G relates to 50% of the Restricted Rights granted under the FY21 Equity Incentive Plan (Tranche 3) which had a performance period of 1 July 2020 to 30 June 2024 ('Performance Period').

Under the terms of the grant, these Restricted Rights did not carry any distribution or voting rights prior to vesting, however, recipients were entitled to receive distribution equivalent securities at the time of vesting equal to the
