Section 708A Cleansing Notice

26 September 2024: This notice is given by De. Mem Limited (**DEM** or the Company) (ASX:**DEM**) under section 708A(5)(e) of the Corporations Act 2001 (Cth) (**Corporations Act**).

The Company hereby confirms that:

- (a) The Company issued on 26 September 2024 a total of 692,593 Fully Paid Ordinary Shares (**Shares**), comprising:
 - (i) 500,000 Shares issued pursuant to an exercise of 500,000 performance rights, previously issued under the Company's Employee Incentive Plan, at an exercise price of \$nil per Share; and
 - (ii) 192,593 Shares at a deemed issue price of \$0.135 (13.5 cents) per Share to settle a supplier invoice;
- (b) the Shares were issued without disclosure to investors under Part 6D.2 of the Corporations Act;
- (c) the Company is providing this notice under paragraph 5(e) of section 708A of the Corporations Act;
- (d) as at the date of this notice the Company, as a disclosing entity under the Corporations Act, has complied with:
 - (i) the provisions of Chapter 2M of the Corporations Act as they apply to the Company; and
 - (ii) sections 674 and 674A of the Corporations Act;
- (e) as at the date of this notice, there is no information that is "excluded information" (as defined in sections 708A(7) and 708A(8) of the Act) which is required to be disclosed by the Company.
