NOTICE OF ANNUAL GENERAL MEETING

Business of the Meeting

ORDINARY BUSINESS

1. Financial Statements and Reports

To receive and consider the financial statements of the Company, together with the Directors' Report (including Remuneration Report) and Auditor's Report, for the financial year ended 30 June 2024.

Except as set out in Resolution 1, there is no requirement for Shareholders to vote on a resolution or adopt these reports. Accordingly, no resolution will be put to Shareholders on this item of business.

The Company's external auditors will be present at the Meeting to answer questions regarding the audit and the Auditor's Report.

NOTES RELATING TO VOTING

1. Entitlement to vote

The Directors have determined that persons who are registered holders of shares in the Company as at **9.00am** (Melbourne time) on Sunday, 10 November 2024 will be entitled to attend and vote at the AGM as a shareholder. Share transfers registered after that time will be disregarded in determining entitlements to attend and vote at the Meeting.

Shareholders who do not plan to attend the AGM are encouraged to appoint a proxy to participate in the AGM and vote on their behalf. To be effective, your proxy appointment must be received **no later than the Proxy deadline** (see Note 2(g) below).

Shareholders of the Company's shares may vote on all items of business, subject to the voting restrictions described in this Notice. If Shareholders are in doubt as to how they should vote, they should seek advice from their accountant, solicitor, or other professional advisor without delay.

2. Proxies

- a. Votes at the Meeting may be given personally or by proxy, attorney, or representative.
- Each Shareholder has a right to appoint one or two proxies. A proxy need not be a shareholder of the Company.
- c. If a Shareholder is a company, it must execute the appointment of proxy under its common seal or otherwise in accordance with its Constitution or the *Corporations Act 2001 (Cth)*.
- d. Where a Shareholder is entitled to cast two or more votes, the shareholder may appoint two proxies and may specify the proportion or number of votes each proxy is appointed to exercise.
- e. If a Shareholder appoints two proxies, and the appointment does not specify the proportion or number of the Shareholder's votes, each proxy may exercise half of the votes. If a Shareholder appoints two proxies, neither proxy may vote on a show of hands.
- f. A proxy must be signed by the Shareholder or their attorney who has not received any notice of revocation of the authority. Proxies given by corporations must be signed in accordance with corporation's constitution and *Corporations Act 2001* (*Cth*).
- g. To be effective, proxy forms must be received by the Company's share registry (Computershare Investor Services Pty Limited) no later than 48 hours before the commencement of the Meeting, this is no later than 9.00am (Melbourne time) on Sunday, 10 November 2024. Any proxy received after that time will not be valid for the scheduled Meeting.

3. Voting by attorney

A shareholder entitled to participate in and vote at the AGM is entitled to appoint an attorney to participate in and vote on behalf of the shareholder.

The attorney may not vote at the meeting unless the instrument appointing the attorney, and the authority under which the instrument is signed (or a certified copy of the authority) are received by the Company in the same manner and by the same time as outlined in the Proxy Form.

4. Appointment of Corporate representatives

Any body corporate that is a shareholder, or that has been appointed as a proxy, must appoint a person to act as its representative at the AGM. The appointment must comply with the requirements of section 250D of the *Corporations Act 2001 (Cth)*.

The representative must lodge a formal notice of Appointment of Corporate Representative signed in accordance with section 127 of the *Corporations Act 2001 (Cth)* or the constitution of the corporation with the Company's Share Registry prior to the AGM through the contact details outlined in the Proxy Form. The Appointment of Corporate Representative can also be handed in at the AGM when registering as a corporate representative.

6. Voting restrictions

Resolution 1: Remuneration Report

The Company will disregard any votes cast on this Resolution (in any capacity) by or on behalf of a member of the Key Management Personnel (being those persons described as such in the 2024 Remuneration Report) or a closely related party of such a member unless the vote is being cast as proxy for a person entitled to vote and that vote is cast:

- a. in accordance with a direction on the Proxy Form; or
- by the Chair of the Meeting ("Chair") as proxy for a person entitled to vote and the Chair has received express authority to vote undirected proxies as the Chair sees fit; or
- by a holder acting solely in a nominee, trustee, custodial or other fiduciary capacity on behalf of a beneficiary provided the following conditions are met:
 - the beneficiary provides written confirmation to the holder that the beneficiary is not excluded from voting and is not an associate of a person excluded from voting on the Resolution; and
 - (ii) the holder votes on the Resolution in accordance with directions given by the beneficiary to the holder to vote in that way.

Accordingly, if you intend to appoint a member of Key Management Personnel as your proxy, please ensure that you direct them how to vote. If you appoint the Chair as your proxy and you do not direct the Chair how to vote, you will be expressly authorising the Chair to exercise the proxy even if the relevant resolution is connected directly or indirectly with the remuneration of a member of the Key Management Personnel of the Company.

If the Chair is appointed as a proxy for a person who is permitted to vote on Resolution 1, the Chair will vote any proxies which do not indicate on their Proxy Form the way the Chair must vote, in favour of this Resolution. In exceptional circumstances, the Chair may change their voting intention, in which case an ASX announcement will be made. **Resolution 2: Re-election of David Paul Blight as a Director** There are no voting exclusions on this Resolution.

Resolution 3: Election of JoAnne Maree Stephenson as a Director

There are no voting exclusions on this Resolution.

7. Questions from shareholders

Lifestyle Communities welcomes your feedback.

During the meeting, discussion will take place on all items of the business. Attendees will be provided with a reasonable opportunity to ask questions and make comments.

Questions and comments may be grouped or amalgamated if there are multiple questions or comments on the same topic. While the Chair will endeavour to respond to all questions there may not be sufficient time available to address all questions and comments raised.

Written questions can also be submitted in advance of the Meeting. Questions for the Company's Auditor, PwC, must relate to:

- a. the conduct of the audit;
- b. the preparation and contents of the audit report;
- c. the accounting policies adopted by the Company in relation to the preparation of its financial statements; and
- d. the independence of the Auditor in relation to the conduct of the audit.

General questions can be submitted up to 24 hours before the meeting. In accordance with s250PA of the *Corporations Act 2001 (Cth)*, questions specifically for the Auditor should be received by **9.00am (Melbourne Time) on Tuesday, 5 November 2024** so that they can be circulated in good time.

9. Technical difficulties

Technical difficulties may arise during the AGM. This may include local technical difficulties experienced by shareholders, such as poor internet connection.

The Chair has discretion as to whether and how the AGM should proceed if a technical difficulty arises. In exercising this discretion, the Chair will have regard to the number of shareholders impacted and the extent to which participation in the business of the meeting is affected.

Where the Chair considers it appropriate, he may continue to hold the meeting and transact business, including conducting a poll and voting in accordance with valid proxy instructions. For this reason, shareholders are encouraged to vote in advance of the AGM even if they plan to attend the meeting via the Live Webcast.



Explanatory Notes

Explanatory Memorandum

Item 1 – Financial Statements and Reports

The *Corporations Act 2001 (Cth)* requires that the financial report and the reports of the Directors and Auditor be laid before the AGM. There is no requirement for shareholders to vote on these reports. Shareholders will be given a reasonable opportunity to raise questions and make comments on these reports and on the management of the Company at the AGM.

In accordance with the *Corporations Act 2001 (Cth)*, a reasonable opportunity will be given to shareholders, as a whole, to ask questions or make comments on the management of the Company at the AGM.

Resolution 1: Remuneration Report

The *Corporations Act 2001 (Cth)* requires a non-binding resolution to be put to shareholders for the adoption of the Remuneration Report. The Remuneration Report is included in the Company's 2024 Annual Report.

The 2024 Annual Report is available on the Investor Information section of the Company's website, <u>www.lifestylecommunities.com.au/investors</u>.

The Remuneration Report includes information on:

- the remuneration policies adopted by the Board;
- the relationship between those policies and the Company's performance; and
- the remuneration details of each Director and Key Management Personnel.

At the AGM, the Chair will give shareholders a reasonable opportunity as a whole to ask questions about or comment on the Remuneration Report.

The shareholder vote on this Resolution is advisory only and will not bind the Directors or the Company.

The Board will consider the outcome of the vote and comments made by shareholders on the Remuneration Report at this Meeting when reviewing the Company's remuneration policies. If 25% or more of the votes that are cast are voted against the adoption of the Remuneration Report at two consecutive Annual General Meetings, shareholders will be required to vote at the second of those Annual General Meetings on a resolution (a "spill resolution") that another meeting be held within 90 days at which all of the Company's Directors other than the Managing Director must be offered up for election.

Key Management Personnel (including Directors) and their closely related parties must not cast a vote on the Remuneration Report, unless as holders of directed proxies for shareholders eligible to vote on this Resolution. It is noted that at the Company's last AGM, the votes cast against the Remuneration Report represented less than twenty-five (25%) per cent of the total votes cast and accordingly, a spill resolution will not under any circumstances be required for the Meeting.

Voting Exclusions

A voting exclusion statement is included under Note 6 of the Explanatory Notes.

Recommendation

The Board recommends that shareholders vote in favour of adoption of the Remuneration Report.

Resolution 2: Re-election of David Paul Blight as a Director

David Paul Blight is due to retire from the Board in accordance with the Constitution and, being eligible, offers himself for re-election.

David was appointed to the Board of Lifestyle Communities Ltd on 15 June 2018. He is also the Board Chair and a member of the Audit & Risk Committee and the People & Culture Committee.

David has over 40 years of experience in property investment, development and fund management in Australia and globally. He was previously the CEO and cofounder of ARA Australia, the Australian business of Singapore based ARA Asset Management, prior to its acquisition by the ESR Group in January 2022. He also held the position of Chief Investment Officer of ARA Private Funds, the private equity real estate business of the ESR Group.

David's previous roles include Vice Chairman of ING Real Estate and Global Chairman and CEO of ING Real Estate Investment Management based in The Netherlands. He has also held senior executive positions with Armstrong Jones, Mirvac Group and APN Property Group.

Voting Exclusions

There are no voting exclusions on this Resolution.

Recommendation

The Board (with Mr Blight abstaining) recommends that shareholders vote in favour of this Resolution as it considers that his qualifications, experience, skills, and expertise are appropriate for the Board position and will enable him to act in the best interests of the Company and its shareholders.

Resolution 3: Election of JoAnne Maree Stephenson as a Director

JoAnne Maree Stephenson is due to retire from the Board in accordance with the Constitution and, being eligible, offers herself for election.

JoAnne was appointed to the Board of Lifestyle Communities Ltd on 1 July 2024. She is also a member of the Audit & Risk Committee and the People & Culture Committee.

JoAnne is an experienced company director in listed, private and government organisations. She is a Chartered Accountant with expertise in financial management, risk management, audit and corporate governance gained through an executive career over 25 years, including senior Partner roles, with KPMG.

JoAnne is currently on the Boards of ASX entities Challenger Limited, Helia Group Ltd and Qualitas Limited.

Voting Exclusions

There are no voting exclusions on this Resolution.

Recommendation

The Board (with Ms Stephenson abstaining) recommends that shareholders vote in favour of this Resolution as it considers that her qualifications, experience, skills, and expertise are appropriate for the Board position and will enable her to act in the best interests of the Company and its shareholders.
