This App 3G relates to the exercise of 467,289 rights. The Company's obligation to provide ordinary shares upon the vesting and exercise of rights was satisfied by the Company arranging for the transfer of 467,289 existing and unallocated fully paid ordinary shares held by the trustee of the Baby Bunting Employee Share Plan Trust.

In total, 480,763 rights were exercised. The balance of the shares required upon exercise of the rights were provided upon the issue of 13,474 shares (see Appendix 2A lodged on this date).

Following the vesting and exercise of these rights, there are 636,526 service rights outstanding.
