

Acquired Divisions Overview	 Armstrong Legal - Criminal Law (AL-CL) practice manages all aspects of criminal offences (traffic, drugs, sexual assault, violence, fraud etc) corporate crime and "criminal adjacent" work which extends to Coronial Inquests, Commissions of Inquiry and Torts against the Police. Armstrong Legal - Family Law (AL-FL) practice manages all aspects of family law including property matters, parenting matters, child support, spousal maintenance and separation and divorce. 	 armstronglegal.com.au website and certain related business assets . AL-CL & AL-FL are divisions of Armstrong Legal, a business owned and operated by the seller, Go To Court Lawyers Pty Ltd (GTC) (acquired Dec-19). The armstronglegal.com.au website and certain related business assets are owned by GTC Legal Pty Ltd (GTC Legal) AFL will acquire the key components of these divisions being debtors, work in progress, client matters and direct staff

Rationale	•	The acquisition is consistent with our stated growth strategy and represents a move into our third area of law, being criminal law We are now diversified across family law, contested wills and estates and criminal law All three sectors have good prospects for continued organic growth. Criminal law is currently confined to NSW, but we will look to expand into other states in the short to medium term. All three sectors are characterised by the absence of significant national players The acquisition includes the armstronglegal.com.au website which is one of the nation's premier sources of search activity and resultant lead volume across the three areas of law we now operate across	-	Both this acquisition and the previous one mean we can better leverage our cost base by adding revenue and accordingly gross margin (after fee earner costs) with minimal incremental overhead costs such that our bottom-line profitability grows at a disproportionately higher rate Synergies across all three practice areas, whilst not expressly quantified, contribute to this better leveraging of our cost base Three practice areas of law operating on a more national basis in time present potential career benefits to our team members, with opportunities to expand into new areas of law and new geographical locations as more advancement opportunities arise

Criminal Law

- Armstrong Legal Criminal Law is a well-regarded and well-established criminal law firm that has operated for over 40 years, with a high-quality team led by Angela Cooney (nationally) and Trudie Cameron (Sydney) with three accredited specialists in criminal law
- Criminal Law is a vast area of law, encompassing all kinds of criminal offences (traffic, drugs, sexual assault, violence, fraud, etc.), corporate crime and "criminal adjacent" work which extends to Coronial Inquests, Commissions of Inquiry, Regulatory Prosecutions (e.g. WH&S) and Disciplinary Tribunals
- Armstrong Legal Criminal Law is proudly a Doyles' Recommended Criminal Law firm, whilst several of the team are themselves Doyles' recognised:
 - Angela Cooney Recommended Traffic & DUI lawyer
 - Trudie Cameron Leading Criminal Defence lawyer and Recommended Traffic & DUI lawyer
 - Sophie Ogburn Criminal Law Rising Star
- Both Angela and Trudie have been with the business for 9-10 years, joining in 2015 and 2014 respectively, well before the GTC acquisition of Armstrong Legal in December 2019
- The existing operations, comprised of a team of 8, are centred around NSW from the Sydney office, but previously the coverage extended to Victoria, Queensland, the ACT and Western Australia
 - Previously when Armstrong Legal Criminal Law operated on a more national basis, annual revenue was in excess of \$10 million. This is not a short-term goal but does highlight the growth opportunity as we look to grow back beyond NSW in the short to medium term
- Following an initial period of bedding the new business into the AF Legal Group we will look to expand geographically largely through organic expansion leveraging the existing AF Legal Group office network
- Criminal Law is characterised by a very high proportion of monies in trust up front, and as such has an advantageous cash flow profile



Family Law

- Armstrong Legal Family Law has a well-established and high-quality team of 4 led by Laura Lincoln, with existing operations largely centred around NSW from the Sydney office
- The team of family law specialists are highly experienced in relation to property matters, parenting matters, child support, spousal maintenance and separation and divorce.
- Family Law remains the core business of the AF Legal Group, even with our recent expansion into both Contested Wills & Estates and Criminal Law.
- Armstrong Legal Family Law will be quickly integrated into the Watts McCray teams based out of Sydney, to better leverage our resources and to cross-pollinate across the respective family law team members
- The armstronglegal.com.au website generates the majority of the leads for the transferring NSW family team team, but also fields additional interstate queries which were previously distributed throughout the greater GTC network
 - Whilst not factored into our projections these could generate similar volume which will now be available to our non-NSW national family law network
 - Additionally, there were potentially NSW leads in excess to the Armstrong Legal Family Law team capacity which may be available to our preexisting Watts McCray team. Again, these are not factored into our projections



Contested Wills & Estates – digital strength

- The deal sees us obtain the armstronglegal.com.au website which is among the most highly visited non-government legal websites in Australia
 - Site drove contested combined enquiries in excess of 22 per day (*from 1 Apr 23 to 31 Mar 24) with over 75% of these queries related to contested wills and estates, criminal or family law
 - Our marketing and digital teams are working closely with all Armstrong Legal leaders, evaluating modifications to enhance the content to further enhance throughput and conversion
 - We will explore referral options for the areas of law we currently do not cover
- AF Legal Group's own increasingly valuable website resources have benefited from a strong focus on SEO/organic traffic combined with ongoing thought leadership (e.g. Research Report), PR and a strong content/article strategy
 - 137% in new file openings (all FY24 v FY23)
 - 158% in website users for the digitally driven Australian Family Lawyers with organic growing 175% (259k growing to 454k)
 - Acquisition efficiency showing positive trends, increasing lead growth at a declining cost of acquisition (media spend \$\J39%)




