**NOTICE OF ANNUAL GENERAL MEETING**

Notice is given that the 2024 Annual General Meeting (**AGM** or the **Meeting**) of shareholders of GTN Limited (**GTN** or the **Company**) will be held:

The Explanatory Memorandum accompanying this Notice of Meeting provides additional information on matters to be considered at the AGM. The Explanatory Memorandum, Entitlement to Attend, Vote section and Voting Form are all part of this Notice of Meeting.

**A. CONSIDERATION OF REPORTS**

The first item of business is to receive and consider the Financial Report, the Directors' Report, and the Independent Auditor's Report of the Company for the financial year ended 30 June 2024.

All shareholders can view the Company's 2024 Annual Report which contains the Financial Report, the Directors' Report and the Independent Auditor's Report for the year ended 30 June 2024 on the Company's website at <http://www.gtnetwork.com.au/investor-centre/?page=reports>

**B. QUESTIONS AND COMMENTS**

Following consideration of the Reports, the Chair will give those shareholders attending the meeting in person a reasonable opportunity to ask questions about and make comments on the business of the Meeting, the management of the Company or about the Company generally.

The Company's external auditor, Grant Thornton (**Auditor**), will attend the Meeting and there will be a reasonable opportunity for those shareholders present to ask the Auditor questions relevant to:

- a. the conduct of the audit;
- b. the preparation and content of the Independent Auditor's Report;
- c. the accounting policies adopted by the Company in relation to the preparation of the financial statements;  
and
- d. the independence of the Auditor in relation to the conduct of the audit.

The Chair will also give the Auditor a reasonable opportunity to answer written questions submitted by shareholders that are relevant to the content of the Independent Auditor's Report or the conduct of the audit.

## C. ITEMS FOR APPROVAL

### **Resolution 1: Election of Director – Craig Coleman**

To consider and, if thought fit, pass the following as an **ordinary resolution** of the Company:

*“That Craig Coleman, who retires in accordance with article 10.3(b)(ii) of the Company’s Constitution and being eligible, is elected as a Director of the Company.”*

### **Resolution 2: Remuneration Report**

To consider and if thought fit, pass the following as a **non-binding ordinary resolution** of the Company:

*“That the Company’s Remuneration Report for the financial year ended 30 June 2024, be adopted.”*

Note: The Remuneration Report is contained in the 2024 Annual Report (available at <http://www.gtnetwork.com.au/investor-centre/?page=reports>). Please note that, in accordance with section 250R(3) of the *Corporations Act 2001* (Cth) (**Act**), the vote on this resolution is advisory only and does not bind the Directors or the Company.

### **Voting Exclusion Statement for Resolution 2**

A vote on Resolution 2 must not be cast (in any capacity) by, or on behalf of, the following persons:

- a. a member of the Key Management Personnel (**KMP**) whose remuneration details are included in the 2024 Remuneration Report; or
- b. a closely related party of such a KMP (including close family members and companies the KMP controls).

However, a person described above may cast a vote on Resolution 2 as a proxy if the vote is not cast on behalf of a person described above and either:

- a. the proxy appointment is in writing that specifies the way the proxy is to vote on the resolution; or
- b. the vote is cast by the Chair of the Meeting and the appointment of the Chair as proxy:
  - i. does not specify the way the proxy is to vote on the resolution; and
  - ii. expressly authorises the Chair of the Meeting to exercise the proxy even if the resolution is connected directly or indirectly with the remuneration of a member of the KMP.

“Key management personnel” and “closely related party” have the same meaning as set out in the Act.

In accordance with section 250BD of the Act, a vote must not be cast on Resolution 2 as a proxy by a member of the KMP at the date of the AGM, or a closely related party of those persons, unless it is cast as proxy for a person entitled to vote in accordance with their directions. This restriction on voting undirected proxies does not apply to the Chair of the Meeting where the proxy appointment expressly authorises the Chair of the Meeting to exercise undirected proxies even if the resolution is connected, directly or indirectly, with the remuneration of the KMP.

## **ENTITLEMENT TO ATTEND AND VOTE**

### **Attendance at the AGM**

Shareholders may attend the AGM in person at Dexus Place, Level 15, 1 Farrer Place, Sydney. Shareholders attending the meeting will need their Shareholder Reference Number (**SRN**) or Holder identification Number (**HIN**). This number is located at the top of your Voting Form.

If you are unable to attend the meeting in person you may:

- lodge questions online before the AGM at [www.linkmarketservices.com.au](http://www.linkmarketservices.com.au); and
- vote on the resolutions to be considered at the AGM by completing and lodging your Voting Form in accordance with the instructions set out below – this includes an option to lodge your votes online ahead of the AGM.

### **Voting on resolutions to be considered at the AGM**

This section sets out important information about how Shareholders can vote on the resolutions to be considered at the AGM.

#### ***Voting entitlements***

In accordance with regulation 7.11.37 of the *Corporations Regulations 2001* (Cth), the Board has determined that persons who are registered holders of shares of the Company as at 7:00pm (Sydney time) on Wednesday, 20 November 2024 (**Effective Time**) will be entitled to attend and vote at the AGM as a shareholder.

If more than one joint holder of shares is present at the AGM (whether personally, by proxy or by attorney or by representative) and tenders a vote, only the vote of the joint holder whose name appears first on the register will be counted.

#### ***Voting by poll***

Voting on each of the proposed resolutions at this Meeting will be conducted by a poll (rather than on a show of hands) as required by the Act.

#### ***Direct Voting***

In accordance with article 9.22 of the Company's Constitution, the Directors have:

- determined that a Shareholder who is entitled to vote on a Resolution at the AGM is entitled to a direct vote in respect of that Resolution; and
- approved rules governing direct voting (**Rules**), a copy of which is available on the Company's website <http://www.gtnetwork.com.au/investor-centre/>

Any shareholder who submits a direct vote agrees to be bound by the Rules.

#### ***Direct voting before the AGM***

In accordance with article 9.22 of the Company's Constitution, Shareholders may vote directly on the Resolutions to be considered at the AGM.

Shareholders who wish to exercise a direct vote before the AGM should lodge a Voting Form by no later than 11:00am (Sydney time) on Wednesday, 20 November 2024. Details of how to lodge your Voting Form are set out in the section below headed "How to Submit Voting Forms".

Shareholders who do not lodge a valid Voting Form by this time will only be able to vote at the AGM by attending the AGM at the location referred to above and voting in person.

Shareholders who wish to exercise a direct vote before the AGM should ensure that they tick box A on the Voting Form. If you tick box A to lodge a direct vote, you are voting directly on each Resolution and are not appointing a proxy to vote on your behalf. If you wish to appoint a proxy, please tick box B on the Voting Form and follow the instructions below under the heading, "Appointment of Proxies".

Shareholders lodging a direct vote may include in the Voting Form the number of shares to be voted for or against any Resolution by inserting the percentage or number of shares to be voted in each manner. If no percentage or share number is inserted, a voting direction will be taken to apply to all shares held by the Shareholder. If any Shareholder purports to vote more than their total number of shares, excess votes will be disregarded.

### ***Appointment of Proxy***

All Shareholders as at the Effective Time who are entitled to attend and vote at the AGM may appoint an individual or a body corporate for that purpose. If a body corporate is appointed as a proxy, that body corporate must ensure that it appoints a corporate representative in accordance with section 250D of the Act to exercise its powers as proxy at the AGM.

A shareholder may appoint up to two proxies and specify the proportion or number of votes each proxy may exercise. If the shareholder does not specify the proportion or number of votes to be exercised, each proxy may exercise half of the shareholder's votes.

A proxy need not be a shareholder of the Company.

If you wish to appoint a proxy for this AGM, please use the Voting Form and tick box B.

**IMPORTANT:** If you appoint the Chair of the Meeting as your proxy, or the Chair becomes your proxy by default, and you do not direct your proxy how to vote on resolution 2 then by submitting the proxy form you will be expressly authorising the Chair to exercise your proxy on that resolution, even though the resolution is connected, directly or indirectly, with the remuneration of the KMP.

### **How to submit Voting Forms**

If a Voting Form is signed under a power of attorney, it must be accompanied by the original or a certified copy of the power of attorney or other authority under which the Voting Form is signed.

To be valid, a Voting Form must be received by the Company in the manner stipulated above. The Company reserves the right to declare invalid any Voting Form not received in this manner.

## **Corporate Representatives**

A body corporate which is a shareholder, or which has been appointed as a proxy, is entitled to appoint any person to act as its representative at the AGM. The appointment of the representative must comply with the requirements under section 250D of the Act. The representative must ensure that Link Market Services receives a properly executed letter or other document confirming its authority to act as the company's representative prior to the Meeting. A "Certificate of Appointment of Corporate Representative" form may be obtained from the Company's share registry or online at [www.linkmarketservices.com.au](http://www.linkmarketservices.com.au).

## **Shareholder questions**

To allow time to collate questions and prepare answers, please submit any questions by 5:00pm (Sydney time) on Friday, 15 November 2024. Questions will be collated and, during the AGM, the Chair will seek to address as many of the more frequently raised topics as possible. However, there may not be sufficient time available at the AGM to address all topics raised. Please note that individual responses will not be sent to shareholders.

Any shareholder attending the meeting in person will be able to ask questions.

## **Conduct of Meeting**

GTN is committed to ensuring that its shareholder meetings are conducted in a manner which provides those shareholders (or their proxy holders) who attend the meeting with the opportunity to participate in the business of the meeting in an orderly fashion and to ask questions about and comment on matters relevant to the business of the meeting or about the Company generally.

GTN will not allow conduct at any shareholder meeting which is discourteous to those who are present at the meeting, or which in any way disrupts or interferes with the proper conduct of the meeting. The Chair of the meeting will exercise his powers as the Chair to ensure that the meeting is conducted in an orderly and timely fashion, in the interests of all attending shareholders.

## **EXPLANATORY MEMORANDUM**

This Explanatory Memorandum has been prepared for the information of shareholders of the Company (**Shareholders**) in relation to the business to be conducted at the Company's AGM to be held at 11:00am (Sydney time) on Friday, 22 November 2024.

The purpose of this Explanatory Memorandum is to provide Shareholders with information that is reasonably required by Shareholders to decide how to vote upon the resolutions. Subject to any abstentions noted below, the Directors unanimously recommend Shareholders vote **in favour** of all Resolutions. The Chair of the Meeting intends to vote all available undirected proxies in favour of all Resolutions.

Resolution 1, regarding the election of a Director, is an ordinary resolution, which requires a simple majority of votes cast by Shareholders present and entitled to vote on the resolution.

Resolution 2, relating to the Remuneration Report, is advisory only and does not bind the Directors or the Company.

### **Resolution 1: Election of Director – Craig Coleman**

Craig Coleman was appointed as a Non-Executive Director of GTN pursuant to article 10.7 of GTN's Constitution (that is, as a casual vacancy) on 7 June 2024. ASX Listing Rule 14.4 provides that a Director appointed to fill a casual vacancy or as an addition to the Board must not hold office (without re-election) past the next annual general meeting of the entity. Therefore, in accordance with article 10.3(b)(ii) of the Constitution, Craig retires from office at the conclusion of the AGM and is eligible for election as a Director of the Company. If shareholders do not approve the election of Craig, then he will cease to be a Director at the conclusion of this Meeting.

Prior to Craig's appointment as a Director, the Company completed several background and screening checks with no adverse findings.

Craig is Co-Founder and Managing Partner of Viburnum Funds Pty Ltd (Viburnum). Viburnum and certain affiliates hold approximately 47.3% of the shares of GTN and Craig is regarded as Viburnum's representative on the Board and accordingly he is not considered an independent director of the Company having regard to the relevant factors as set out in the ASX Corporate Governance Principles & Recommendations (4<sup>th</sup> edition).

Craig is an experienced senior executive and director, with a 30-year career spanning banking and finance, corporate advisory, and funds management. His experience in Australian public securities includes leadership of an ASX publicly listed company and many public company directorships. Craig is a Co-Founder of Viburnum Funds, a business focused active ownership investment manager operating since 2007. He has primary responsibility for the firm's Public Equities investing and the Strategic Equities Fund.

Prior to Viburnum Funds, Craig was Managing Director of the ASX listed Home Building Society Ltd and prior to this held several senior executive positions during a ten-year career with ANZ Banking Group Ltd, including Managing Director Banking Products, Managing Director Wealth Management, Non-Executive Director E\*TRADE Australia Ltd and Head of Retail Banking New Zealand.

Craig holds a Bachelor of Commerce from the University of Western Australia.

Prior to submitting himself for election, Craig confirmed that he has sufficient time to properly fulfil his duties and responsibilities to the Company.

The Board supports the election of Craig as he will contribute to the Board with his senior executive and Non-Executive Director experience in other listed entities, which will complement the skills of the existing directors.



**Board Recommendation:**

*The Directors, with Craig Coleman abstaining, unanimously recommend Shareholders vote **in favour** of this Resolution 1.*

**Resolution 2: Remuneration Report**

Section 250R(2) of the Act requires that the section of the Directors' Report dealing with the remuneration of directors and KMP of the Company (**Remuneration Report**) be put to the vote of shareholders for adoption by way of a non-binding vote.

Shareholders can view the full Remuneration Report in the 2024 Annual Report which is available on GTN's website at <http://www.gtnetwork.com.au/investor-centre/?page=reports>.

Broadly, the Remuneration Report details the remuneration policy for the Company and:

- explains the structure of and rationale behind the Company's remuneration practices and the link between the remuneration of executives and the Company's performance;
- sets out remuneration details for each Director and for each executive with authority and responsibility for directing the affairs of the Company; and
- discusses the relationship between the policy and Company performance.

Following consideration of the Remuneration Report, the Chair of the Meeting will give Shareholders a reasonable opportunity to ask questions about, or make comments on, the Remuneration Report. A resolution that the Remuneration Report be adopted will then be put to the vote. The vote on this resolution is advisory only and does not bind the Directors or the Company. However, the Board will take the outcome of the vote into account in setting remuneration policy for future years.

**Board Recommendation:**

*Noting that each director has a personal interest in their own remuneration from the Company as set out in the Remuneration Report, the Directors unanimously recommend Shareholders vote **in favour** of this Resolution 2.*
