# Update on Scheme – Despatch of Scheme Booklet and Letter to Auswide Shareholders

Auswide Bank Ltd (ASX: ABA) (Auswide or the Company) refers to its announcements made on 22 October 2024 and 23 October 2024 in relation to the proposal for MyState Bank Limited (a wholly owned subsidiary of MyState Limited (ASX:MYS)) to acquire 100% of the fully paid ordinary shares in Auswide by way of a scheme of arrangement (Scheme), and the orders made by the Supreme Court of New South Wales that Auswide convene and hold a meeting of Auswide shareholders to consider and vote on the Scheme (Scheme Meeting) and approving the distribution to Auswide shareholders of an explanatory statement providing information about the Scheme and notice of Scheme Meeting (Scheme Booklet).


