# **Listings and Capital Raisings**

- In October 2024, total new capital quoted was \$3.1 billion, compared to \$24.2 billion in the previous corresponding period (pcp). The total quoted market capitalisation of entities de-listed was \$6.7 billion compared to \$0.6 billion in the pcp.
- Total net new capital quoted was negative \$3.6 billion, compared to \$23.6 billion in the pcp. On an October YTD basis total net new capital quoted was negative \$19.6 billion, compared to \$33.5 billion in the pcp.

# Trading – Cash Markets (including equities, interest rate and ETP trades)

- In October 2024, the average daily number of trades was up 19% on the pcp. The average daily value traded onmarket of \$5.433 billion was up 10% on the pcp.
- Volatility (as measured by the average daily movement in the All Ordinaries Index) was 0.5% in October, compared to 0.6% in the pcp.
- Future volatility (as measured by the S&P/ASX 200 VIX) in October was an average of 12.3, down 9% on pcp.
