# JOHNS LYNG GROUP LIMITED (ASX: JLG) ASX & Media Release

## **Results of 2024 Annual General Meeting**

In accordance with Listing Rule 3.13.2 and section 251AA of the Corporations Act 2001 (Cth), Johns Lyng Group Limited advises the results of its 2024 Annual General Meeting.

All resolutions put to the meeting were decided by a poll. Details of the resolutions, the proxies received, and the votes cast on the poll in respect of each resolution are set out in the attached results.

In accordance with ASX Listing Rule 3.13(2)(f), Johns Lyng Group Limited advises that more than 25% of the votes cast on Item 2 were against the adoption of the 2024 Remuneration Report, which constitutes a 'second strike' for the purposes of the Corporations Act 2001 (Cth). As a result of the second strike, the Company was required to put a spill Resolution to the vote and it should be noted that the spill resolution did not pass.

Following last year's 'first strike' on the Remuneration Report, the Company spent considerable time reflecting on the feedback from shareholders on our remuneration practices. As a result, substantial changes were made to both short-term and long-term elements of executive remuneration. In our discussions with shareholders heading into this AGM, those changes have been universally well-received. Nevertheless, we acknowledge that further work on this front needs to be done and this will be examined by the Board and its Remuneration Committee throughout 2025.
