

## RESULTS OF ANNUAL GENERAL MEETING AND BOARD CHANGES

Pentanet Ltd (ASX: **5GG**) (**Company**) is pleased to advise of the outcome of resolutions put to the Annual General Meeting (**AGM**) of shareholders held today, 14 November 2024. All resolutions were conducted by a poll and were carried. The Company notes that Resolution 6 was passed as a special resolution. Mr Cornish remains a substantial shareholder and actively involved in the strategic direction of Pentanet.
