### **Lovisa Holdings Limited (LOV) – Results of 2024 Annual General Meeting**

In accordance with ASX Listing Rule 3.13.2 and section 251AA of the Corporations Act 2001 (Cth), Lovisa Holdings Limited (ASX:LOV) advises the voting results of all resolutions and proxies received as set out in the attached proxy and voting summary.

Resolutions 3, 4 and 5 were passed by way of a poll with the required majority of votes, however Item 2 in relation to the 2024 Remuneration Report was not passed, with the outcome of the poll constituting a second strike under the Corporations Act 2001 (Cth). As a result of the second strike against the remuneration report, Item 6 Contingent Spill Resolution was put to the meeting and defeated, therefore a separate Spill Meeting will not be required.
