The Non-executive Director (NED) Share Rights Plan was introduced in 2021 to assist NEDs in building their equity holdings. Under the Plan, NEDs may sacrifice at least 20% of their pre-tax base fee in return for a grant of rights. Rights are allocated in two tranches and vesting occurs following the release of the half year results and full year financial results. On vesting, the NED is allocated one share for each vested right, and the shares are subject to dealing restrictions for a period of three to 15 years or the date the NED ceases to be a director. No price is payable on vesting of the rights. No performance conditions apply to the rights and the shares allocated on vesting will be purchased on market. The securities the subject of this notice are share rights vesting following the release of the FY24 full year results.
