Intention to Reconstitute Pacific Smiles Board

The Board of Pacific Smiles Group Limited (ASX: PSQ) (**Pacific Smiles**) refers to its announcement on 22 November 2024 stating that, in the Board's view, Genesis Bidco now has the ability to obtain effective control of Pacific Smiles.¹ Additionally, Genesis Bidco disclosed today that it has Voting Power of approximately 59.2% in Pacific Smiles.

In light of the above, the Board announces that it is intended that the Chairman of Pacific Smiles, Ms Giselle Collins, as well as two Non-Executive Directors will step down from the Board following Pacific Smiles' next Board meeting on 16 December 2024.

The Board also intends to appoint three nominees of Genesis Bidco – Dr Michael Caristo (intended to be appointed Chairman), Mr Chris Yoo and Ms Tara Hariharan – as Directors of Pacific Smiles with effect from the close of that same Board meeting, subject to the standard Director checks. For the purposes of ASX governance guidance, these individuals will not be considered independent Directors. Refer to Appendix A for further background on the intended Director appointments.

Board Recommendation & Offer Close

The Pacific Smiles Board continues to unanimously recommend, in the absence of a superior proposal emerging, that Pacific Smiles Shareholders **ACCEPT THE CASH OFFER** from Genesis Bidco.

The Offer Period has been automatically extended and is now scheduled to close at **7.00pm (Sydney time)** on **Thursday, 12 December 2024**. Genesis Bidco has reserved the right to extend the Offer further or to let it close.

Prior to this, Mr Hariharan was a management consultant at Bain & Company where she primarily focused on the Healthcare, Financial Services and NFP/Charity sectors. Ms Hariharan holds a Bachelor of Laws and Bachelor of Commerce from the University of Sydney. She received Honours (First Class) in Health Economics.
