Results of Annual General Meeting

Top Shelf International Holdings Ltd (ASX: TSI) (**Top Shelf** or the **Company**) advises that in accordance with ASX Listing Rule 3.13.2 and Section 251AA of the *Corporations Act 2001* (Cth), Resolution 2 as set out in the Notice of Meeting was duly passed by the requisite majority by a poll at the Annual General Meeting (**AGM**) of the Company held today. Resolution 1 seeking approval for the adoption of the Remuneration Report for the year ended 30 June 2024 was not put to the AGM because the Annual Report was not made available to shareholders before the date of the AGM as it has not yet been finalised or audited.

Details of the voting results and proxies in respect of Resolution 2 is set out in the attached summary.

The remaining business of the AGM was adjourned to 2:00pm AEDT on 28 February 2025 in accordance with rule 7.6(f) of the Company's constitution to allow shareholders a reasonable opportunity to consider the Company's annual report, including the financial report, directors' report and auditor's report for the year ended 30 June 2024, which the Company expects will be made available to shareholders in early 2025. Resolution 1 will be put to shareholders at a re-convened AGM.
