Decmil awarded \$47m contract at Vestas's Warradarge Wind Farm Stage 2

Macmahon Holdings Limited (ASX:MAH) (**Macmahon** or the **Company**) is pleased to announce its wholly owned subsidiary, Decmil, has been awarded a \$47 million contract for the Civil Balance of Plant (**CBoP**) on Stage 2 of the Warradarge Wind Farm by Vestas Australia Wind Technology Pty Ltd.

The contract is with Vestas, a leading global wind energy company, for the project located 200kms north of Perth, Western Australia. The project will be funded and developed by Bright Energy Investments - a partnership between Synergy and the private sector.

Decmil's scope of work includes the design and construction of the CBoP for an additional 30 turbines to the existing wind farm, including wind turbine bases and 21km of access tracks.

The works will commence immediately with completion anticipated in January 2026.

This award will add to Macmahon's secured orderbook and builds upon Decmil's extensive experience in Wind Farm CBoP projects, including the completed Warradarge (Stage 1), Yandin, and Ryan Corner Wind Farms.

Macmahon's Managing Director and CEO, Michael Finnegan, said:

"Following its acquisition by Macmahon, Decmil has made a strong start, securing new, strategically aligned work. This project is a continuation of Decmil's successful history of delivering Civil Balance of Plant projects for wind farms across Australia.

Delivering civil infrastructure to support renewable energy projects is a priority for Macmahon and a key component in creating a more scalable and diversified business."
